* The total EUR 11.1 billion allocated to Member States programmes includes the initial allocations to Member States as agreed by the co-legislators and EUR 1.9 billion of transfers from other Funds, as well as top-ups to finance specific projects that bring Union's added value in the policy areas covered by the three Funds (AMIF, BMVI, ISF) as well as to finance solidarity actions, such as the transfer of asylum seekers and refugees under AMIF. These top-ups are funded from the so-called Thematic Facility which is a flexibility instrument under the Home Affairs Funds, making it possible to address emerging or unforeseen needs.
