Introduction

In Europe today migration and security are areas of great importance that have many effects on the EU, and will continue to do so in the years to come. For both areas each EU Member State has its own concerns and issues, however there also many commonalties and shared challenges. A practical and effective way of managing migration and tackling security includes joint and coordinated approaches between Member States.

The EU funds provide financial contributions for strengthening the area of freedom, security and justice and for developing the common EU policy on asylum and immigration based on solidarity. The funds run for a period of 7 years (2014-2020) and are designed to be flexible and responsive to both the common and differing challenges and opportunities faced by Member States in relation to migration and security.

There follows a selection of projects being implemented by EU Member States and Associated States under the Migration and Security Funds of the EU.

The [Asylum, Migration and Integration Fund](#) (AMIF) promotes the efficient management of migration flows and the implementation, strengthening and development of a common EU approach to asylum and immigration.

The Internal Security Fund (ISF) provides EU financial support to implement law enforcement cooperation under the internal security strategy and the management of the Union's external borders. The ISF is composed of two instruments covering the areas of [borders and visa](#) (ISF Borders and Visa) and [police cooperation, preventing and combating crime, and crisis management](#) (ISF Police).

Each fund is divided into two parts: funds managed directly by the European Commission and funds managed by the EU Member States (known as shared management). The Member States implement their multiannual national programmes covering the whole of the 2014-2020 period. These programmes are prepared, implemented, monitored and evaluated by the responsible authorities in the Member States, along with the relevant stakeholders, including civil society.

The Asylum, Migration and Integration Fund (AMIF) was set up for the 2014-2020 period, with a total of EUR 3.137 billion for the 7 years. It promotes the efficient management of migration flows and the implementation, strengthening and development of a common EU approach to asylum and immigration. This fund has the following four specific objectives.

- **Asylum.** Strengthening and developing the *common European asylum system* by ensuring that EU legislation in this field is efficiently and uniformly applied.
- **Legal migration and integration.** Supporting legal *migration* to Member States in line with labour market needs and promoting the effective *integration* of non-EU nationals.
- **Return.** Enhancing fair and effective strategies, which contribute to combating with an emphasis on the sustainability and effectiveness of the return process.
- **Solidarity.** Making sure that the Member States most affected by migration and asylum flows can count on solidarity from other Member States.

Special financial incentives for Member States have been built into the AMIF to support the **Union resettlement programme**, with a focus on common EU priorities. A similar financial mechanism is envisaged for the transfer of beneficiaries of international protection from a Member State with high migratory pressure to another.

ACHIEVING THE KEY OBJECTIVES

The largest share of the total amount of the AMIF (approximately 88 %) is channelled through **shared management**. Member States implement their multiannual national programmes, covering the whole of the 2014-2020 period. These programmes are prepared, implemented, monitored and evaluated by the responsible authorities in the Member States, in partnership with the relevant stakeholders in the field, including civil society.

THE FUND'S BENEFICIARIES

All Member States except Denmark participate in the implementation of this fund. Examples of beneficiaries of the programmes are state and federal authorities, local public bodies, non-governmental organisations, humanitarian organisations, private and public law companies and education and research organisations.

AMIF Projekt: NIPE Gesamtprojekt – Psychotherapie für Flüchtlinge (AT/2015/PR/1005)

Projektidee: Der Rucksack an psychischen Belastungen, den Flüchtlinge mitbringen, ist größer als die Plastiktasche in ihrer Hand. 25-40% aller Ankommenden leiden unter einer posttraumatischen Symptomatik. Was dann hilft, ist Psychotherapie. Die NIPE Zentren bieten diese an – mit geschulten Dolmetscher/innen und hohen Qualitätsstandards.

Ziele: Psychotherapie und psychologische Behandlung haben zum Ziel, Menschen durch Trauer und Erschütterung zu begleiten, hin zu einem als gut und sinnvoll erlebtem Leben.

Tätigkeiten: Bei NIPE arbeiten gut eingespielte Teams von Dolmetscher/innen und Psychotherapeut/innen mit geflüchteten Kindern und Erwachsenen.

Ergebnisse: Von den rund 2500 pro Jahr Behandelten wird die Mehrzahl mit einer deutlichen Verbesserung der Symptomatik die Therapie abschließen.

Besonderheiten: NIPE ist ein Netzwerk von 10 Psychotherapiezentren in ganz Österreich, das gemeinsame Behandlungsstandards entwickelt hat.

Challenge. The backpack of mental stress that the refugees bring with them is bigger than the plastic bag in their hand. 25-40 % of all arrivals suffer from post-traumatic symptoms. What then helps is psychotherapy. And that's what NIPE centres do — with trained interpreters and high quality standards.

Objectives. Psychotherapy and psychological treatment aim to accompany people through mourning and shock towards a life that is seen as worth living.

Activities. At NIPE centres, well-trained teams of interpreters and psychotherapists work with refugee children and adults.

Results. Of the approximately 2500 patients treated per year the majority will conclude their therapy with a clear improvement in their symptoms.

What makes this project particularly interesting? NIPE is a network of 10 psychotherapy centres in Austria that have developed common treatment standards.

AMIF project: Versterking van maatwerk-assistente vrijwillige terugkeer (BE/2016/PR/1603)



De eerste doelstelling van het project is het geven van bijkomende re-integratiesteun aan 280 persoon die vrijwillig terugkeren naar hun land. Terugkeerders worden voor hun terugkeer begeleid (uitwerken van persoonlijk re-integratieplan) en krijgen steun na terugkeer in samenwerking met lokale partners in

het land van herkomst. De re-integratiesteun is divers: opzetten van micro-business, job begeleiding en ontwikkelen van vaardigheden, speciale ondersteuning voor kwetsbare terugkeerders,

Daarnaast wil het project ook specifieke projecten met betrekking tot vrijwillige terugkeer opzetten in onder meer Kameroen, Mongolië en Marokko. Dit om een publiek te bereiken en te informeren dat moeilijk te bereiken is inzake vrijwillige

terugkeer. De mogelijkheden om de vrijwillige terugkeer naar deze landen te versterken worden onderzocht en geanalyseerd.

Een derde doelstelling van het project is het bewustzijn rond vrijwillige terugkeer te vergroten door infosessies te organiseren.



AMIF project: Strengthening tailor-made assisted voluntary return (BE/2016/PR/1603)

The first aim of the project is to provide additional reintegration support to 280 people who return voluntary to their country of origin. Returnees are assisted during the preparations for their return by establishing a personal reintegration plan and are given post-return support in cooperation with local partners in the country of origin. The reintegration assistance provided can be diverse: setting up micro-business activities, accompaniment towards employment and skill development, special support for vulnerable returnees, etc.

The scheme's second aim is to set up country-specific voluntary return projects in Cameroon, Mongolia and Morocco, amongst other countries. This is in order to inform a public that is difficult to reach with regard to voluntary return. The possibilities for reinforcing voluntary return to these countries are examined and analysed.

A third goal of the project is to raise awareness of voluntary return by organising activities such as information sessions.

The project aims at providing information to and facilitating the integration of third-country nationals (TCNs) legally staying in Bulgaria, with a special focus on vulnerable persons, through consultations, language training, social orientation and cultural adaptation.

Project beneficiary: International Organisation for Migration.

Other partners: Red Cross Bulgaria.

Project (estimated) duration: 2.3.2016-2.3.2017.

Total cost of the project (EUR): 2 200 000:

- EU contribution: 112 478.16;

Activities. Providing consultations and information to improve conditions for integration, social orientation and cultural adaptation; introduction to the social system, political structure, cultural traditions etc.; Bulgarian language courses for TCNs, including those with international protection, in Sofia and Bourgas.



Results. Improving conditions for the integration of TCNs, their social inclusion and professional career; improving the ability of TCNs to understand and communicate in Bulgarian.

Activities: providing psychosocial support and health services, implementing workshops and courses for asylum seekers, activities with the local community with a view to preventing discrimination and xenophobia.

Providing access to relevant information for asylum seekers in an innovative and efficient manner; creating a safe and calm environment for asylum seekers through daily activities; empowering, learning skills and preparing for integration and a more effective life for asylum seekers in the community.

AMIF έργο: ΚΕΝΤΡΑ ΕΞΥΠΗΡΕΤΗΣΗΣ ΜΕΤΑΝΑΣΤΩΝ (ΚΕΜ) (CY/2016/PR/0020)



Σκοπός του έργου είναι η δημιουργία, λειτουργία και διαχείριση των Κέντρων Εξυπηρέτησης Μεταναστών τα οποία παρέχουν υποστηρικτικές υπηρεσίες σε Υπήκοους Τρίτων Χωρών (ΥΤΧ) προκειμένου να επιτυγχάνεται αποτελεσματικότερη και γρηγορότερη ένταξη τους στην κοινωνία της Κύπρου. Τα Κέντρα λειτουργούν σε κεντρικά σημεία στις τέσσερις μεγαλύτερες Επαρχίες της Κύπρου (Λευκωσία, Λεμεσό, Λάρνακα και Πάφος). Είναι στελεχωμένα με κατάλληλα εκπαιδευμένο επιστημονικό προσωπικό, υιοθετώντας μια προσωποκεντρική προσέγγιση που ανταποκρίνεται αποτελεσματικά στις γενικές και ειδικές ανάγκες της ομάδας

στόχου. Προσφέρονται μεταξύ άλλων υπηρεσίες όπως ενημέρωση και πληροφόρηση για τα δικαιώματα και τις υποχρεώσεις τους, βοήθεια για εξεύρεση εργασίας και στέγης, ενημέρωση για ευκαιρίες εκπαίδευσης, συμβουλευτική στήριξη κτλ. Επιπλέον πραγματοποιείται άμεση και έμμεση επικοινωνία με τις αρμόδιες κρατικές υπηρεσίες και τμήματα, ΜΚΟ και εθελοντικές οργανώσεις.

Είναι η πρώτη φορά στην περίπτωση της Κύπρου, που σχεδιάζεται και υλοποιείται μια συστηματική προσπάθεια σε πολλαπλά επίπεδα του πεδίου της κοινωνικής ένταξης και ενσωμάτωσης ΥΤΧ στις τοπικές κοινωνίες.

AMIF project: Migrant information centres (MIC) (CY/2016/PR/0020)

The main purpose of the project is to establish and operate the migrant information centres in order to help third-country nationals that live in Cyprus to enter Cypriot society and to know better their rights and obligations.

The centres operate in the four major cities of the island: Nicosia, Limassol, Larnaca and Paphos. Properly trained and qualified personnel, undertaking a person-centred approach, support migrants' general and special needs. The centres' service provision includes direct and indirect advocacy on migration, employment, housing, educational opportunities, healthcare, culture and social inclusion information, etc. In addition there is cooperation with relevant governmental organisations and departments, NGOs and voluntary agencies.

What makes this project interesting is that this is the first time that a systematic effort has been implemented in this sensitive and highly important field of migrants' social inclusion and integration in the republic.

AMIF Projekt: Integrační centrum Praha VI (CZ/2016/PR/1003)

Hlavním cílem projektu je v souladu s platnou Konceptí integrace cizinců vytváření podmínek pro dlouhodobou, koncepční a udržitelnou podporu integrace cizinců, kteří legálně pobývají na území hlavního města Prahy.

Cílem je provoz centra na podporu integrace cizinců, v rámci kterého je cílové skupině poskytováno široké spektrum integračních služeb jako poradenství, jazyková výuka, poskytování informací a zprostředkování kontaktu s hostitelskou společností.

Hlavní aktivity centra zahrnují právní a sociální poradenství, výuku českého jazyka, socio-kulturní

kurzy, pořádání integračních multikulturních aktivit a workshopů. Dále jsou organizována pravidelná setkání v rámci krajské platformy a probíhá monitoring cílové skupiny v kraji.

Důsledkem realizace aktivit bude zvýšení soběstačnosti cílové skupiny, její lepší integrace a poklidné soužití s majoritní společností v Praze. Služby budou využity přibližně 7 000 osobami z cílové skupiny.

Integrační aktivity jsou přístupné pro cílovou skupinu na jednom místě a mají synergický efekt. Komplexnost a propojení nabízených služeb jsou klíčovými faktory pro úspěšnou integraci.



AMIF project: Integration Centre Prague VI (CZ/2016/PR/1003)

The main goal is, in compliance with the policy for the integration of third-country nationals, to create conditions for long-term, conceptual and sustainable support for the integration of third-country nationals legally residing in the territory of Prague.

The aim is to operate an integration support centre which would provide a broad spectrum of integration services for the target group, such as counselling, language tuition, provision of information and provision of contact with the host society.

Project beneficiary: Integration Centre Prague, o.p.s, InBáze, z. s., Organisation for Aid to Refugees, Centre for Integration, Association for Integration and Migration.

The main activities include legal and social counselling services, Czech language courses and socio-cultural courses, organisation of integration and multicultural events and workshops. Furthermore, the centre organises regular meetings of the regional platform and monitors the target group in the region.

The activities will increase the self-sufficiency of the target group and lead to their better

integration and peaceful cohabitation with the majority society in Prague. The project expects to provide services to 7 000 people from the target group.

The integration activities are accessible by the target group at one place and they have synergistic effect. The complexity and interconnection of the offered services are the key factors for successful integration.

AMIF Projekt : Tugiisikuteenus (EE/2015/PR/0010)



Probleem: Eesti omavalitsuste sotsiaaltöötajad ei ole hetkel ette valmistatud tööks varjupaigataotlejate ja rahvusvahelise kaitse saanud isikutega, mistõttu on selleks välja koolitatud tugiisikud. Paindlik tugiisikuteenus on end tänaseks õigustanud, kuna nii varjupaigataotlejate majutuskeskustel kui omavalitsustel puudub hetkel piisav inimressurs, et korraldada pagulaste kliendikeskne (s.t. takistustega igakülgset arvestav) vastuvõtt kohaliku omavalitsuse territooriumil. Selle vajaduse täidavad tugiisikud, kes loovad esimese kontakti kohaliku omavalitsusega, sotsiaaltöötajaga, Töötukassaga, kooliga, lasteaiaga jne, eesmärgiga, et klient suudaks neid tegevusi teha lõpuks iseseisvalt.

Eesmärk: Varjupaigataotlejate vastuvõtutingimused ja rahvusvahelise kaitse saanud isikute kohanemine Eestis on paranenud tugiisikuteenus kaudu.

Peamised tegevused:

- Kvaliteetse tugiisikuteenus pakkumine sihtrühmale üle Eesti.

- Rahvusvahelise kaitse saanud inimeste elama asumise korraldamine kohalikesse omavalitsustesse, tööturuteenustele saamine või õppima asumine (koostöös Vao keskusega), kohaliku tasandi koostöömudeli arendamine.
- Rahvusvahelise kaitse saanud isikutele olulise tugivõrgustiku tugevdamine kohalike omavalitsuste territooriumil.
- Väljaspool Vao keskust elavatele rahvusvahelise kaitse saanud perede lastele neile vajaliku huvitegevuse otsimine.
- Rahvusvahelise kaitse saanud isikute vaimse tervise jälgimine ning vajadusel suunamine psühholoogi või psühhiaatri juurde.
- Tõlketöö korraldamine, et abistada sihtrühma liikmeid suhtlusel ametiasutuste ja tugiisikutega.
- Tugiisikute koolitamine ja superviseerimine.

Tulemus: Paranenud on haavatavatesse gruppidesse kuuluvate varjupaigataotlejate ning rahvusvahelise kaitse saanud isikute sotsiaalne toimetulek ja kultuuriline kohanemine Eestis.

AMIF project: Support-person service (EE/2015/PR/0010)

Challenge. Today, a flexible support-person service is needed as there are not enough human resources in either the accommodation centres or local governments to provide client-centred reception of refugees at the local level. Support persons are essential in creating first contact with local government, schools, kindergartens, etc.

Objective. Improve reception conditions for asylum seekers and beneficiaries of international protection in Estonia through the support-person service.

Activities.

- Provide a quality support-person service to the target group all over Estonia.
- Assist refugees in contacting necessary institutions, finding local housing, accessing the local job market, furthering their education and establishing stronger ties with the local community.
- Strengthen the important support networks in the local municipalities and communities.

- Assist in finding recreational activities for the children of the target group.
- Monitor the mental health of beneficiaries and direct them to medical services if needed.
- Organise translation services to assist communication with different institutions and support persons.
- Train and supervise the support persons.

Results. The cultural adaptation and self-management of the beneficiaries of international protection and vulnerable asylum seekers is improved.

AMIF Projekti: Turvapaikanhakijoiden yleisen oikeudellisen neuvonnan tila ja kehittämistarpeet (FI/2015/PR/1439)



Kattavaa tietoa yleisen oikeudellisen neuvonnan saatavuudesta eri paikkakunnilla ja sen yhdenvertaisesta toteutumisesta sekä hakijoiden kokemuksista ei ole ollut.

Tavoitteena oli selvittää turvapaikanhakijoiden yleisen oikeudellisen neuvonnan toteutumista ja kehittämistarpeita sekä löytää erityisen haavoittuvassa asemassa olevien hakijoiden erityistarpeet.

Hankkeessa järjestettiin ryhmäinfoja yli 500 uudelle hakijalle vastaanottokeskuksissa sekä haastateltiin noin 50 turvapaikanhakijaa sekä 40 vastaanottokeskusten johtajaa ja alan ammattilaista.

Tuloksena oli, että yleinen oikeudellinen neuvonta ei toteutunut yhtenäisin käytännöin eikä sisällöin vuonna 2016. Osa hakijoista jäi ilman perustietoa turvapaikkamenettelystä. Erityisen haavoittuvassa asemassa olevien hakijoiden tunnistamiseen tarvitaan ohjeita ja koulutusta.

Tavoite on, että hankkeen kehittämis ehdotukset huomioidaan viranomaisten toiminnan ohjeistuksessa ja suunnittelussa.

Hanketta suunniteltaessa turvapaikanhakijamäärät olivat rajussa kasvussa.

AMIF project: The state and development of general legal advice for asylum seekers in Finland (FI/2015/PR/1439)

From the experiences of asylum seekers it seems that there is a lack of comprehensive information on the availability of general legal advice and its uniform provision in different locations.

To examine the way general legal advice is provided to asylum seekers, the related development needs and the special needs of asylum seekers in a particularly vulnerable position are taken into account.

Group info sessions were organised at reception centres for more than 500 new asylum seekers, and approximately 50 asylum seekers and 40 reception centre directors and other professionals were interviewed.

It was found that the general legal advice practices and content were not uniform in 2016. Not all asylum seekers received basic information about the asylum procedure. Training and

clearer instructions are needed to identify asylum seekers in a particularly vulnerable position.

The goal is that the authorities take account of the project's development proposals when planning and drawing up instructions for the activities.

The project was launched at a time that saw a large increase in the number of asylum seekers.

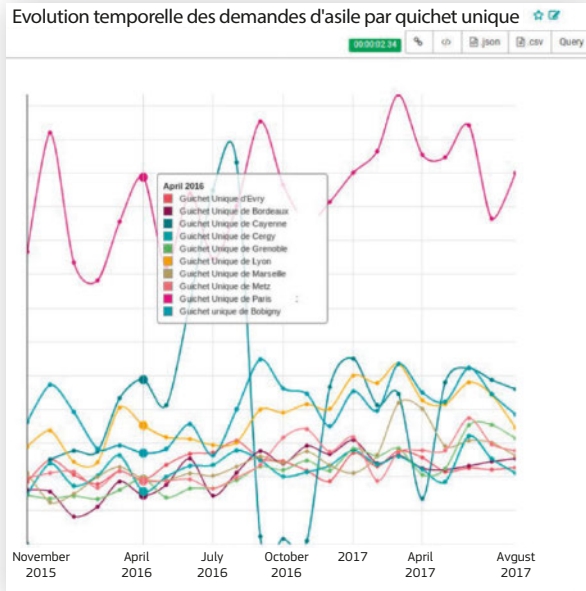

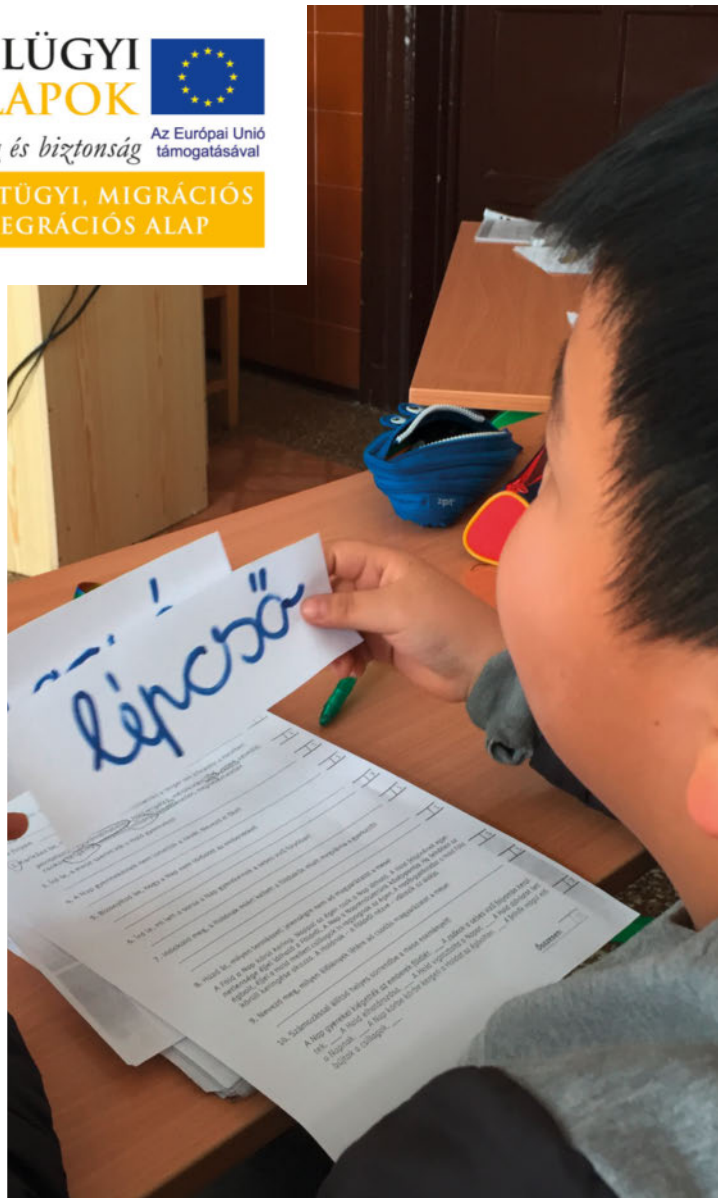
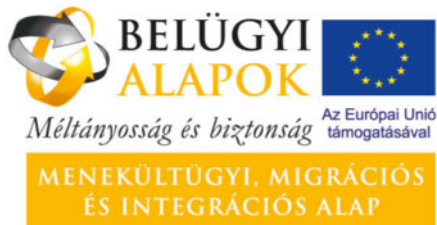

The participating schools complete an eight-step programme within the day-to-day running of the school, including training for school management and staff; engaging with the local community; establishing a diversity committee of students, staff and parents; and producing a diversity code and an anti-racist policy for the school. The 'Yellow flag' programme targets schools with high proportions of third-country nationals, asylum seekers, refugees, travellers and other minority ethnic groups. On successful completion of the programme, participating schools are awarded the yellow flag, which they can fly with pride.

AMIF project: Eigen-Wijs (NL/2015/PR/2015EFA2012)

In Nederland groeien enkele duizenden kinderen van asielzoekers en vluchtelingen op in centrale opvanglocaties. Deze kinderen komen vaak uit heftige situaties uit hun land van herkomst (oorlogssituaties), en hebben veel moeten doorstaan gedurende hun vlucht en reis naar Nederland.



Aangekomen in Nederland zijn er in de leefsituatie knelpunten die het leven voor deze kinderen lastig maken, zoals stress en spanning en daardoor een structureel gevoel van onzekerheid en machteloosheid. Deze kinderen hebben minder makkelijk toegang tot informatie, ondersteuning, hulp en voorzieningen.

Eigen-Wijs richt zich op asielkinderen in de leeftijd van 4 tot en met 17 jaar die in centrale opvanglocaties van het COA verblijven. Hoofddoelstelling is het verbeteren van het welzijn en empowerment van kinderen in asielzoekerscentra. De muziek, voorlichting en spreekuuractiviteiten in Eigen-Wijs maken hen sterker om het leven aan te kunnen in een situatie die inherent onzeker is. Daarnaast zet Eigen-Wijs in op het bieden van samenwerking tussen en met professionals die te maken hebben met deze kinderen en op het versterken van het vangnet en netwerk rond de kinderen.

Beoogde resultaten (streefwaarden) zijn:

- (1) het bieden van specifieke bijstand aan +/- 2600 kinderen die gerekend worden tot de kwetsbare groepen,
- (2) het geven van informatie en bijstand in de gehele loop van de asielprocedure aan +/- 2500 kinderen alsook

In the Netherlands several thousand asylum-seeking and refugee children are growing up in refugee (or reception) centres. These children often come from violent (war) situations in their country of origin and have endured a lot during their flight and travel to the Netherlands. After arriving they face restrictions in their living situation, such as stress

and tension from the sense of uncertainty and helplessness, making life difficult for these children. They do not have easy access to information, support, help or facilities. 'Your own tune' focuses on asylum-seeking children aged 4 to 17 living in central reception centres of the COA (Central Agency for the Reception of Asylum Seekers). The main objective is to improve the welfare and empowerment of children in reception centres. The music, information and consultation activities in 'Your own tune' make children more able to cope with living in a situation that is inherently uncertain. 'Your own tune' also provides cooperation between and with professionals working



and tension from the sense of uncertainty and helplessness, making life difficult for these children. They do not have easy access to information, support, help or facilities.

'Your own tune' focuses on asylum-seeking children aged 4 to 17 living in central reception centres of the COA (Central Agency for the Reception of Asylum Seekers).

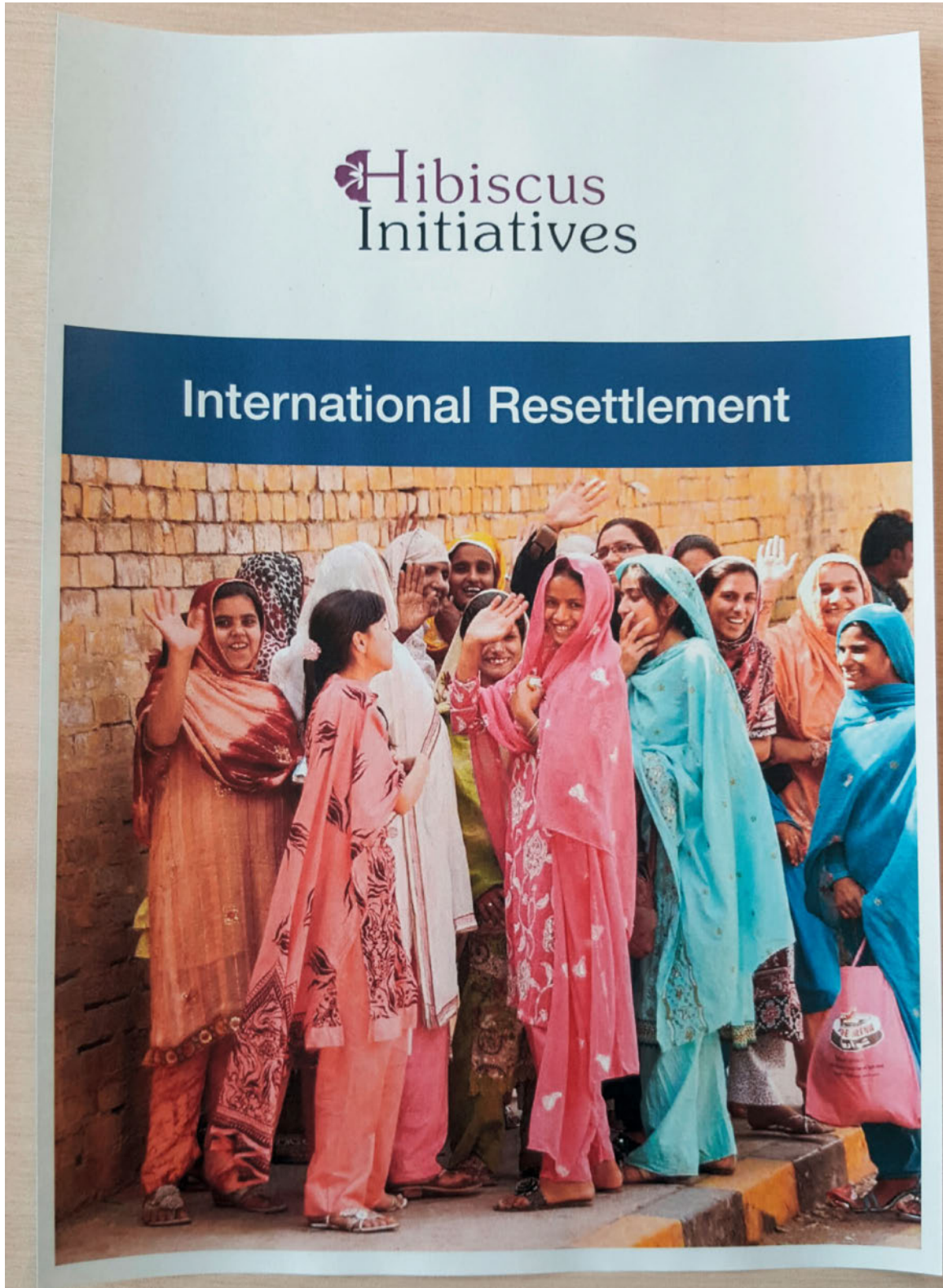

AMIF project: Returns facilitation: Heathrow and Yarl's Wood
IRCs (UK/2016/PR/0024)



AMIF project: Returns facilitation: Heathrow and Yarl’s Wood IRCs (UK/2016/PR/0024)

Key challenge project seeks to address. Return measures to encourage UK immigration detainees to comply with the UK immigration returns process.

Objectives. To facilitate the return of at least 624 UK immigration detainees per year and to provide support through guidance, advocacy and small welfare financial payments to support the resettlement of 240 detainees per month.

Main activities/components of the project. To provide a bespoke level of support for each of its clients that is independent of the immigration removal centre service providers and so is best placed to offer impartial, focused advice and support to detainees via 1-1 sessions, targeted monthly workshops and drop-in sessions for detainees. Expected results. To reduce the average length of time a detainee remains in detention and allow the detainees to make an informed choice about their return and to return home to their country of origin with dignity.

What makes the project interesting? The daily presence and continuity of enhanced welfare provision for detainees ensures the levels of trust that have built up between AMIF project-funded Hibiscus caseworkers and detainees. Specifically focussed workshops encourage traditionally hard to reach nationalities, to comply with the returns process and to engage more fully in activities available to them whilst at the detention centres.

The Internal Security Fund (ISF) was set up for the 2014-2020 period, with a total of EUR 3.8 billion for the 7 years. The fund promotes the implementation of the *internal security strategy*, *law enforcement cooperation* and the *management of the EU's external borders*. The ISF is composed of two instruments: *ISF Borders and Visa* and *ISF Police*.

ACHIEVING THE KEY OBJECTIVES

The ISF Police component of the Internal Security Fund contributes to ensuring a high level of security in the EU. Within this general objective the fund's activities focus on the following two specific objectives.

- **Fighting against crime.** Combating cross-border, serious and *organised crime*, including *terrorism*, and reinforcing coordination and cooperation between law enforcement authorities and other national authorities of Member States, including with *Europol* and other relevant EU bodies and with relevant non-EU and international organisations.
- **Managing risks and crises.** Enhancing the capacity of Member States and the EU to manage security-related risks and crises effectively and preparing to protect people and critical infrastructure against terrorist attacks and other security-related incidents.

For the 2014-2020 period slightly over EUR 1 billion is available for funding actions under the ISF Police instrument, of which EUR 662 million will be channelled through shared management and EUR 342 million through direct management.

Concrete actions to be funded through this instrument include a wide range of initiatives such as setting up and running IT systems, acquiring operational equipment, promoting and developing training schemes and ensuring administrative and operational coordination and cooperation.

THE FUND'S BENEFICIARIES

All Member States except Denmark and the United Kingdom participate in ISF Police. Examples of beneficiaries are state and federal authorities, local public bodies, non-governmental organisations and private and public law companies.

ISF Polizi projekt: CyberKids (AT/2015/PR/0014)

Das Projekt hat den Schwerpunkt "Schutz vor Gefahren für Kinder im Alter von 8 - 12 Jahren im Umgang mit dem Internet". Dafür wurden Zielgruppen definiert: 8 - 10 Jährige (Kinderpolizei/Verkehrserziehung) und 10 - 12 Jährige (Kriminalprävention).

Für Präventionsbeamte wurden Handbücher zielgruppengerecht aufbereitet. Es wurden Methoden entwickelt, die die Zielgruppe 8 - 10 nicht zum Opfer und die 10 - 12 Jährigen nicht zum Opfer oder Täter werden lässt.

Noch ein Ziel war die Ausbildung der Präventionsbeamten mit E-Learning-Modulen und einer Präsenzschiung. Nach der Ausbildung wurden 32 Pilotklassen ausgewählt, die in Summe eine positive Rückmeldung zum Projekt geben.

Das Besondere am Projekt ist die gute Zusammenarbeit der Experten in unterschiedlichen Bereichen, die ein gemeinsames Produkt erstellen konnten und dass eine fundierte Ausbildung für die Präventionsbeamten zur Verfügung gestellt werden konnte, um den Schülern die Inhalte und Methoden altersgerecht präsentieren zu können.



ISF Police project: CyberKids (AT/2015/PR/0014)



The key challenge of the project is 'protection against risks for children aged 8 to 12 using the internet'. The project defines two target groups: 8 to 10 (prevention by provincial traffic department) and 10 to 12 (prevention by crime prevention).

One objective was to create handbooks for the prevention officers. The methods for the target groups should prevent children from 8 to 10 from becoming a victim and children from 10 to 12 from becoming a victim or an offender.

Another objective was the training of prevention officers, which involved an e-learning-module and face-to-face training. After the training course prevention officers visited schools to test the methods (32 classes) and received only positive feedback.

The project shows that collaboration between experts in various specialist fields can produce a handbook of this type and that prevention officers can join a well-established training course to present the content and methods to children aged 8 to 12.

ISF Politie Project: Project Opleiding rond radicalisering in gevangenissen (ISF-P-17-01)



Het centrale objectief van het project ‘Opleiding rond radicalisering in gevangenissen’ is tweeledig: 1. Vermijden dat gedetineerden geradicaliseerd worden tijdens hun verblijf in de gevangenis en 2. De ontwikkeling van een gespecialiseerde benadering van geradicaliseerde individuen tijdens hun detentie. Deze objectieven pogen bereikt te worden via vorming voor personeel van ‘normale’ gevangenissen en door training van gespecialiseerde teams die zullen werken in penitentiaire instellingen met een groter aantal geradicaliseerde gedetineerden.

Op de bijgaande foto’s ziet men de sprekers Nicolas Henin, die maandenlang gegijzeld werd door IS in Syrië, en Mourad Guan, een ge de-radicaliseerde moslim die beiden pakkend getuigen en interessante tools en ideeën kunnen meegeven. Een studiedag met dergelijke sprekers bereikte elke gevangenisdirectie in België die elk met een multidisciplinair team deelnam (directieleden, psychologen, sociaal assistenten, psychiaters, ...), gezien de actualiteit van het thema en de recente aanslagen in Brussel.



ISF Police project: Project on training about radicalisation in prisons (ISF-P-17-01)

The central objective of the project is twofold: 1. prevent detainees from being radicalised during their time in prison; 2. develop a specialised approach to radicalised individuals during their detention. These objectives will be met through training for staff of 'normal' penitentiary institutions and training for specialised teams that will work in penitentiary institutions with a greater number of radicalised detainees.

In the attached pictures we see speakers Nicolas Henin, who was held hostage by the Islamic State in Syria, and Mourad Guan, who could be considered a deradicalised Muslim,

speaking in a moving way about their experiences and providing the audience with interesting tools and ideas. Every prison service in Belgium participated in the seminar with a multidisciplinary team (members of staff, psychologists, social workers, psychiatrists, etc.). The topicality of the issue and the recent attacks in Brussels play a major role in the amount of interest generated.

installing and implementing hardware and software, training 8 000 patrol and traffic police officers to work with the integrated system and testing 50 body-worn video cameras using patrol police officers.

Results. Reduction in possible wrongful activities of police officers when performing traffic control; regular internal controls throughout the territory of the country; decrease in submitted reports of corrupt behaviour by police officers; preventive effect on offenders on the roads.

ISF Αστυνομία έργο: Αγορά εξοπλισμού για καταπολέμηση της τρομοκρατίας (CY/2016/PR/0011)



Το έργο αφορά στην πρόληψη και διαχείριση των συνεπειών της τρομοκρατίας και των κινδύνων που σχετίζονται με την ασφάλεια στην Κύπρο και στην ΕΕ. Ως εκ τούτου αγοράστηκε ή αναβαθμίστηκε εξοπλισμός για πρώτη φορά στην Κύπρο, ως εξής: όχημα διαπραγμάτευσης κρίσεων, κινητός σταθμός διοίκησης, αλεξίσφαιρο όχημα ομαδικής αντιμετώπισης κρίσεων, τηλεκατευθυνόμενα οχήματα, εξειδικευμένος εξοπλισμός διαχείρισης κρίσεων και περιστατικών χημικών-βιολογικών-ραδιολογικών-πυρηνικών-εκρηκτικών υλικών και αντιπυρικές επιχειρησιακές στολές.

Με τη χρήση των οχημάτων και του εξοπλισμού αναμένεται όπως επιτευχθεί βελτίωση των ικανοτήτων διαχείρισης καταστάσεων κρίσης. Hence, the following equipment has been purchased for the first time in Cyprus, or has been upgraded: crisis negotiation vehicle; mobile administration station; bulletproof mass-crisis-response vehicle; remotely operated vehicles; specialised equipment for the management of operations and incidents with chemical/biological/radiological/nuclear/explosive materials; and fire-protection operational suits.

The improvement of crisis management capacity is expected to be accomplished by using vehicles and equipment. The project focuses on strengthening the administrative and operational capacity

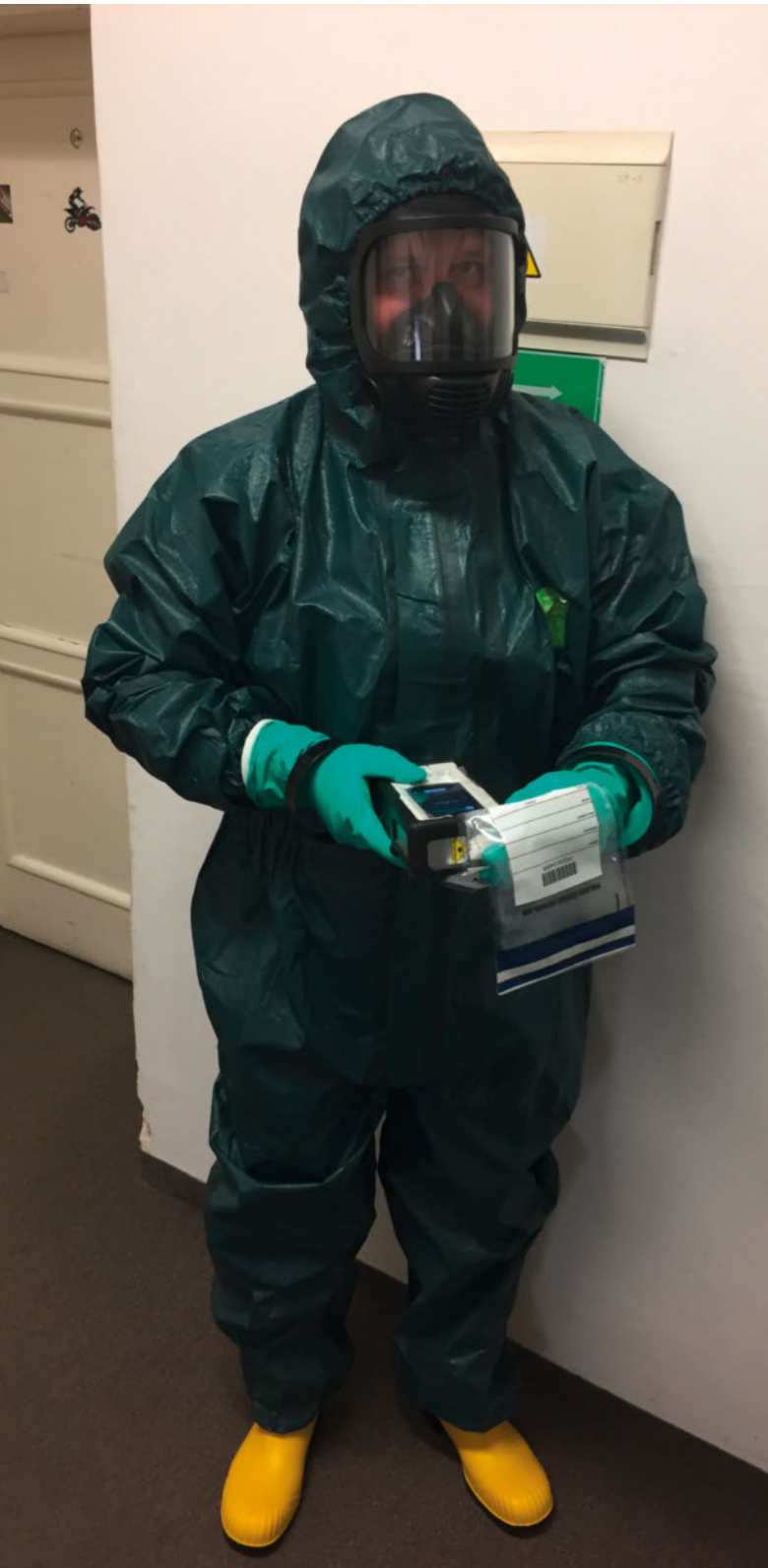

ISF Politsei Projekt: Narkotester (EE/2015/PR/0017)

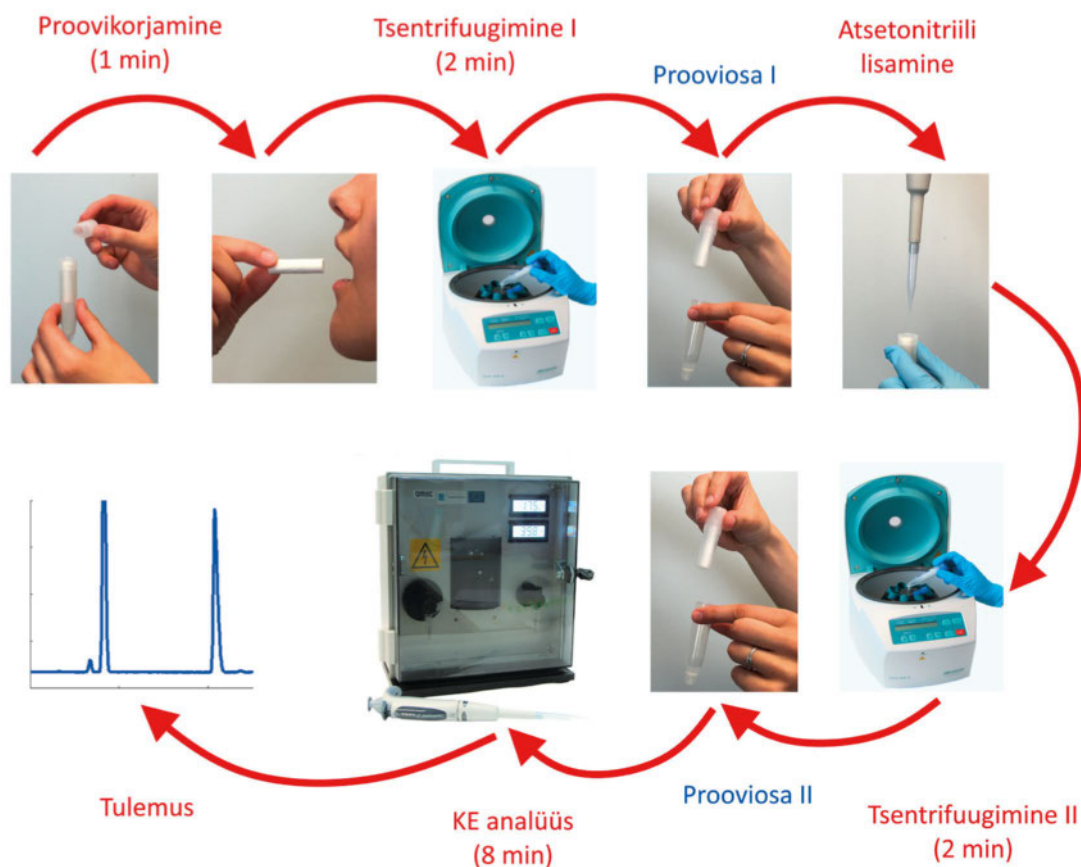
Probleem: Puudub piisavalt täpne narkojoovet tuvastav masin, mida saaks kasutada töendusliku narkotestrina. Kasutatakse kiirtestreid, millega esineb palju valepositiivseid tulemusi, või narkojoobe ekspertiisi, mis on keeruline, ajamahukas, aparatuur on kallis ning suuremõõtmeline ja selle käsitlemine nõuab teatud oskusi.

Eesmärk: Narkojoobe tuvastamine süljest. Seni avastatust täpsemal meetodikal baseeruva töendusliku narkotestri väljatöötamise võimalikkuse analüüs ning, meetodika töötamisel, masina prototüübi loomine.

Peamised tegevused:

- teaduskirjanduse analüüs;
- meetodika väljatöötamine ja arendus;
- seadme ehitamine;
- süljeproovide analüüs.

Tulemus: Leiti tehnoloogia, millega on võimalik avastada süljes narkootilisi aineid juba väikestes kontsentratsioonides. Ehitati maailmas ainulaadne kaasaskantav väga tundlik fluorestsentsdetektor, mis tuvastab narkojoobe sülje analüüsi kaudu 15 minutiga. Masinat plaanitakse edasi arendada, et tulemuse saaks juba hingõhust (sarnaselt alkomeetriga).

Challenge. There is no accurate device that detects drug intoxication and can be used as evidence in court. Rapid testers produce many false positive results and expert analysis of drug intoxication is complicated and time consuming, requiring specific skills and expensive, large-scale equipment.

Objectives. Detect drug intoxication from saliva. Develop a higher-quality, more accurate evidential drug tester than existing ones and create a prototype.

Activities.

- Analysing scientific literature.
- Developing new methodologies.
- Developing a portable device.
- Analysing real saliva samples.

Results. Technology has been found that detects narcotics in saliva even at very small concentrations. A unique, portable, highly sensitive fluorescence detector enables the detection of drug intoxication from saliva within 15 minutes. It is planned that the device will be developed further so that the same results can be achieved from exhaled air (similar to a breathalyser).

ISF Poliisi Projekt: Vaativan teknisen rikostutkinnan laatujärjestelmän kehittäminen (RITU) (FI/2015/PR/1861)



Tekniset rikostutkimuskeskukset suorittavat valtaosan näytteiden alkuvaiheen tutkimuksista. Koko teknisen rikostutkinnan luotettavuuden osoittaminen edellyttää laatujärjestelmän kehittämistä.

Hankkeen päämääränä on saavuttaa valmiudet, jotka Euroopan Unionin neuvosto on puitepäätöksessä asettanut sormenjälki- ja DNA-laboratoriotutkimuksille.

Hankkeessa rakennetaan rikostutkimuskeskuksiin standardiin ISO 17025 pohjautuva laatujärjestelmä ja työ vaatii valtakunnallisten

toimintatapojen kriittistä tarkastelua, kehittämistä ja yhtenäistämistä.

Hankkeessa on yhteistyössä poliisilaitosten kanssa rakennettu valtakunnallinen laatukäsikirja ja ohjeistus huomioiden sormenjälki- ja DNA-tutkimusten kansainväliset käytännöt.

Toimivan laatujärjestelmän rakentaminen vaikuttaa koko teknisen rikostutkinnan laatuun ja kustannustehokkuuteen. Teknisen rikostutkinnan näyttöarvoa on yhä vaikeampi kiistää tuomioistuimissa, kun toiminnan laatu on osoitettu ulkopuolisen ja riippumattoman arvioijan toimesta.

ISF Police project: Facilitation of the accreditation of Finnish crime scene units (FI/2015/PR/1861)

Forensic science laboratories perform most of the laboratory analyses of samples taken from a crime scene in the early stages of an investigation. A quality system will be required in order to demonstrate the reliability of forensic investigation in general.

Objective: to meet the conditions for fingerprinting and DNA profiles set out in the Council framework decision on the accreditation of forensic service providers carrying out laboratory activities.

Activity: building a quality system for forensic science laboratories based on the ISO 17025 standard; this requires the critical evaluation, development and harmonisation of national procedures.

Project beneficiary: Poliisihallitus/National Police Board.

Project duration: 1.1.2015-31.12.2017.

Total cost of the project (EUR): 340 000:

- EU contribution: 255 000;

A national quality manual and quality guidelines have been created in collaboration with police departments, taking into due consideration the international practices for fingerprinting and DNA profiles.

Building an effective quality system affects the quality and cost-effectiveness of forensic investigation as a whole. Forensic evidence will become harder to challenge in court when its quality has been demonstrated by an external and independent evaluator.

ISF Police Projet: Laboratoires mobiles d'analyses documentaires (FR/2016/PR/9037)

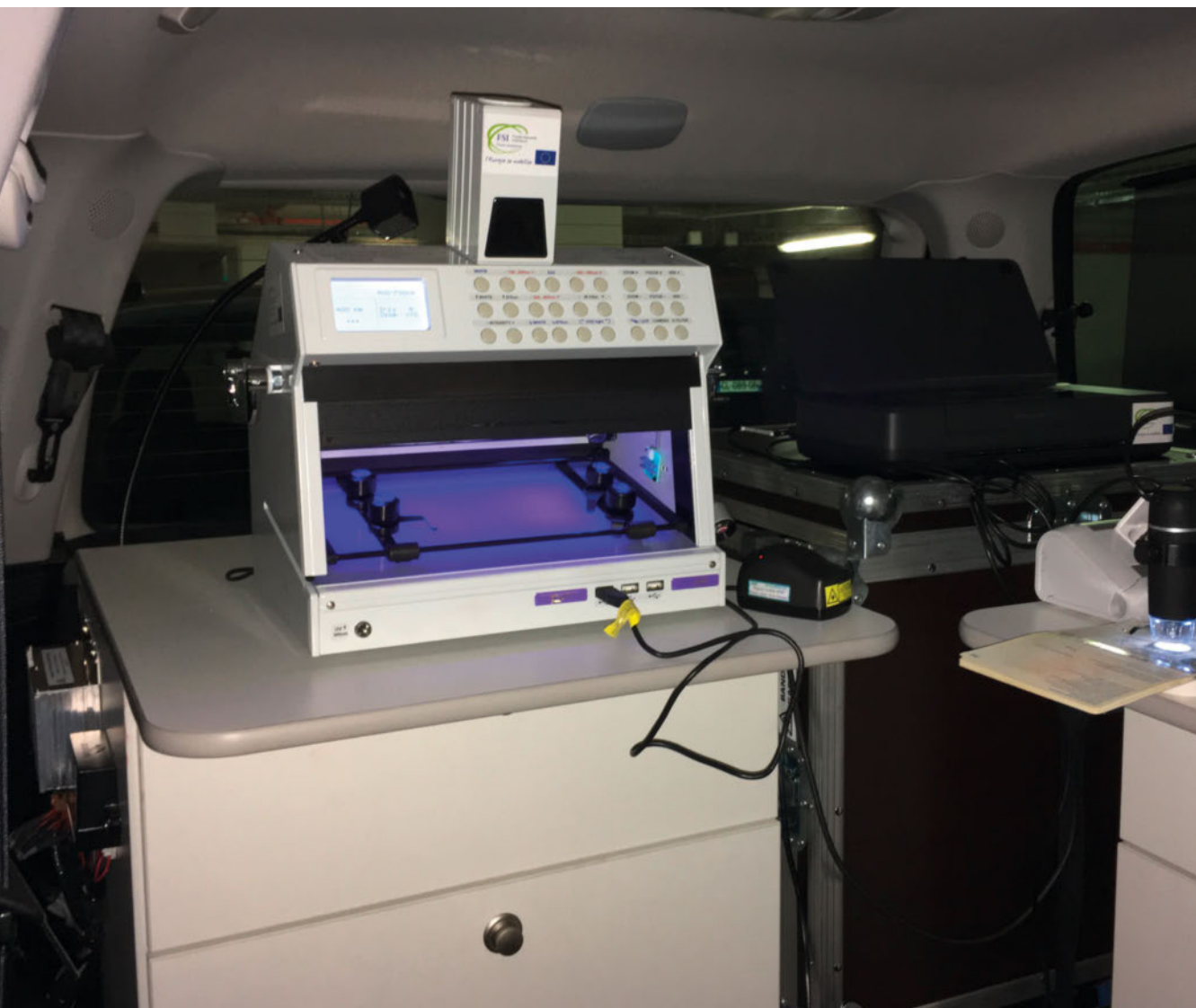
Les laboratoires mobiles d'analyse documentaire (LMAD) sont des véhicules dotés d'équipements permettant de procéder à des examens rapides et complets des documents de voyage ou d'identité sur les lieux mêmes des contrôles diligentés par la police aux frontières.

Ce projet renforce la capacité de la France à lutter contre les fraudes documentaires ou à l'identité, ainsi que contre les multiples formes de criminalité transnationale et terrorisme dont elles constituent l'un des supports.

Il dote la police aux frontières de véhicules spécialement équipés pour la détection des faux documents (microscopes, scanners-détecteurs de faux...).

Les principaux résultats attendus sont une augmentation du nombre de mis en cause et le démantèlement de filières criminelles ou terroristes.

L'intérêt des LMAD réside dans l'expertise immédiate et in situ des documents et dans la réactivité accrue des forces de sécurité intérieure.



ISF Police project: Mobile document-analysis laboratories (FR/2016/PR/9037)



Mobile document-analysis laboratory vehicles are equipped with apparatus that enables rapid and complete examinations of travel or identity documents on the very premises at which border control checks are carried out by the border police.

This project strengthens France's capacity to combat documentary or identity fraud and the many forms of transnational crime, including terrorism.

It provides the border police with vehicles that are especially equipped to detect false documents (microscopes, scanners for detecting fakes, etc.).

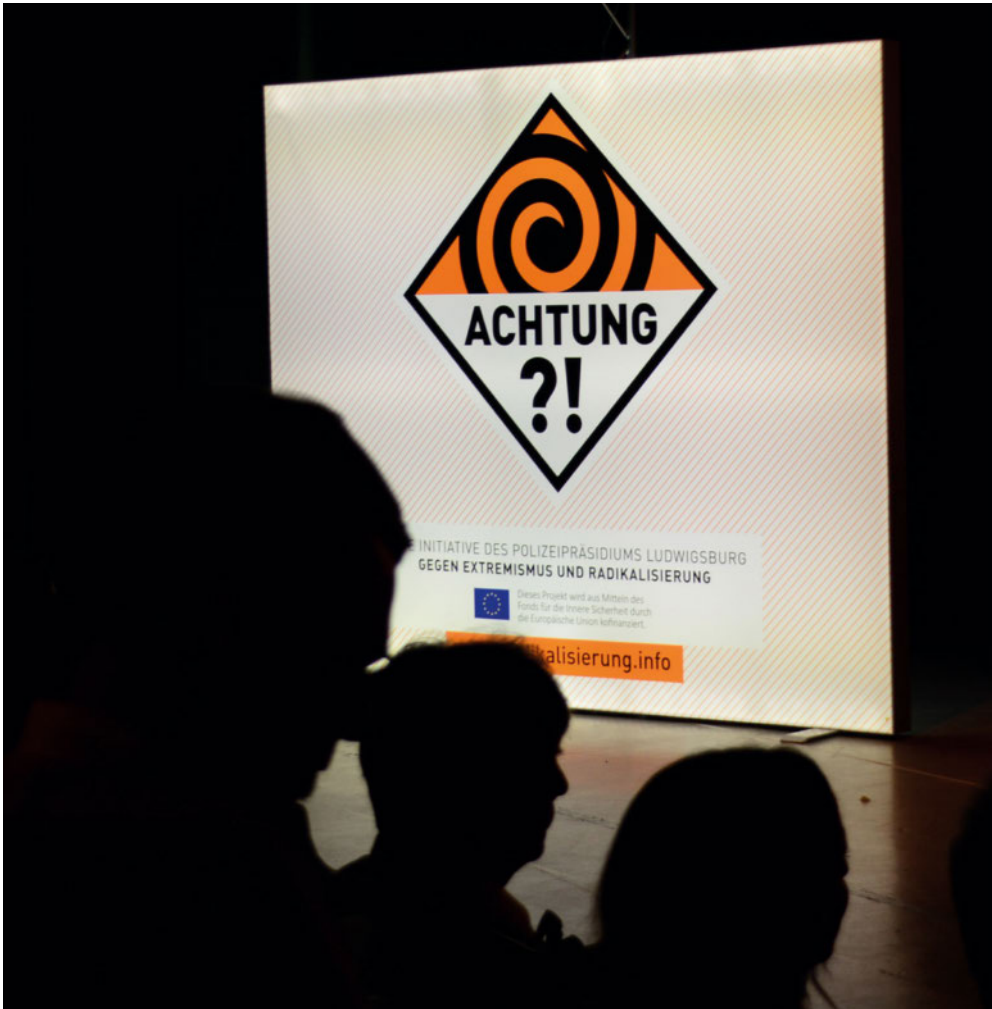

This has resulted in numerous modules that can be booked by schools.

The core of the project is an interactive play for 14- to 16-year-olds about two teenagers who radicalise themselves in different ways — one right-wing, the other Islamist. The play reveals the cross-phenomenal character of the project, which turns against the extremism of any ideology and its propagandists. Supplying modern smartphones, which, through a single application/search interface connected to existing databases (national and European), biometric data (through scanning), driving licences, number plates and documents, will achieve quick and safe searching and identification of vehicles, persons and objects.

Expected results. It is expected that the project will improve police security, prevent unnecessary suffering for citizens and save human and material resources and working time. New technologies will be exploited, more efficient management models will be adopted and the central equipment of the Hellenic Police will be developed, improving the services provided.

At the same time, effective policing will be promoted through more accurate and faster data collection (secure identification of citizens and vehicles), particularly in cases of regular and mass checks. In addition, this project will contribute substantially to the prevention, detection and repression of serious, dangerous and organised crime, with more direct detection and identification of suspect vehicles, persons

In 2016 Cnaipic registered 582 attacks on critical infrastructure, branched 1 851 alerts, carried out 57 surveys and received 101 requests for assistance from public institutions and private operators through the G7 high tech crime 24/7 network.

On the basis of EU Directive 2016/1148, which calls for an increase in the level of cybersecurity of essential service providers, including SMEs and public administrations, it is necessary to implement a national cybercrime system. The objectives of the project are:

- to implement preventive measures by creating a centralised SINC3 platform and a national system to transmit in real time the technical information obtained from Cnaipic and NOSC operational activities;
- to intervene in the realities affected by computer attacks by providing a thorough analysis of the incidents, to create cybernetic security operational nuclear (NOSC) nuclei and to initiate partnerships to promote information sharing.

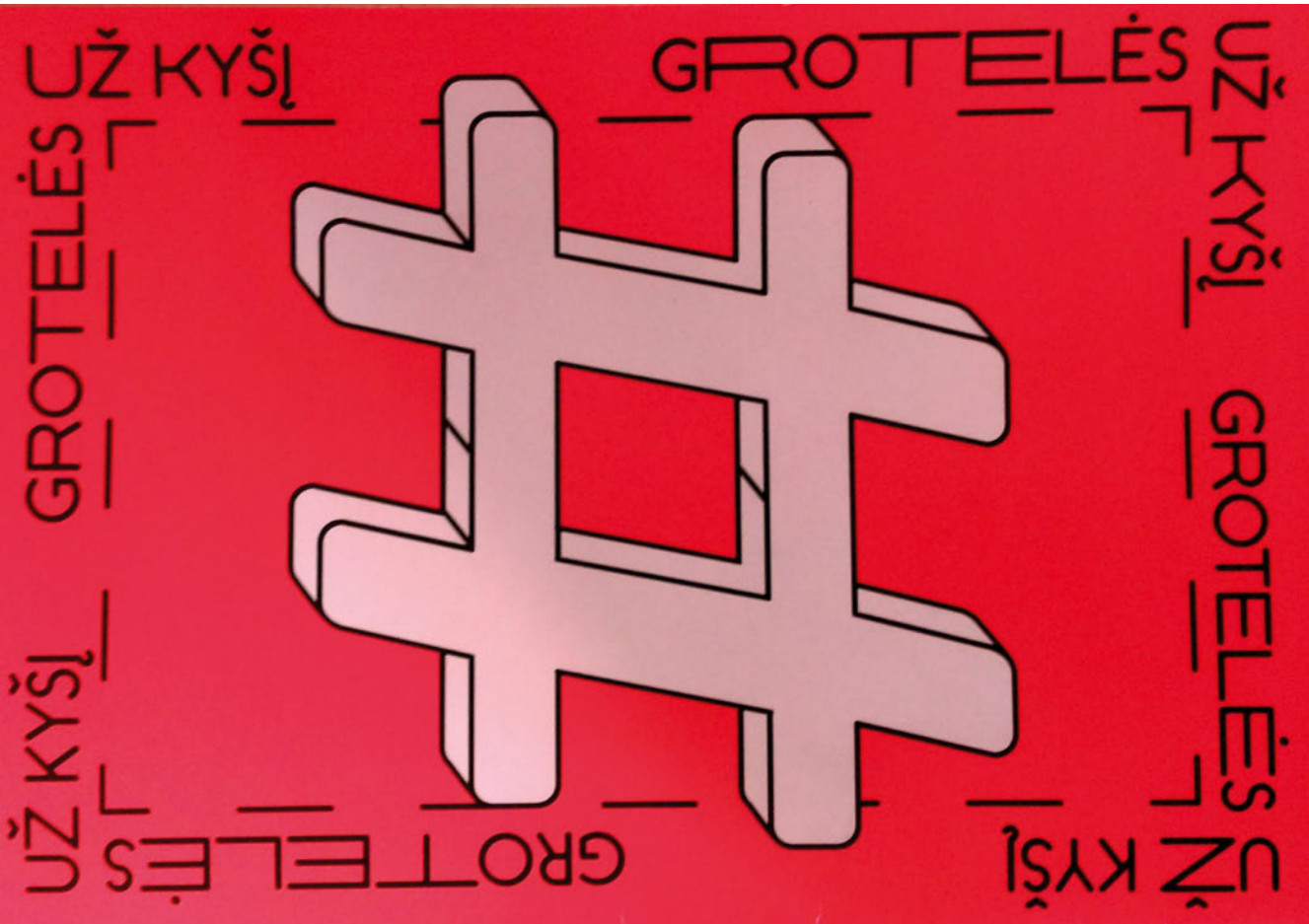

International events have shown that terrorist/criminal organisations have developed advanced capabilities in the field of improvised explosive devices (IEDs). Countless incidents have demonstrated the need for effective counter-IED capabilities. The most appropriate

and feasible option to counter such developments is to equip the explosive ordnance disposal (EOD) platoon with modern response equipment.

Thus, the main activities of this project comprise the following: a low-emission quick-response EOD vehicle; EOD/IEDD specialised equipment such as bomb suits, EOD specialist tools and search equipment; an specialised EOD/IEDD robot capable of conducting remote explosives disposal; a secondary/back-up specialised EOD/IEDD robot; specialised training for the operation of the equipment.

The EOD response vehicle, EOD robots and EOD equipment will be considered vital assets in the conduct of law enforcement security searches, counterterrorism and other security operations in Malta.

Het doel van VITEX 2016 was de samenwerking op het gebied van de vitale infrastructuur te bevorderen. Voor de oefening is een vernieuwend publiek-privaat oefenconcept ontwikkeld voor deelnemers afkomstig van verschillende disciplines en uit verschillende Europese lidstaten (22).

Tijdens VITEX werd er geoefend op basis van een vernieuwend oefenconcept, gebaseerd op scenariodiscussies. Dit hield in dat deelnemers met elkaar in gesprek gingen over mogelijke maatregelen indien de totale stroomproductie in Europa sterk zou afnemen. Het scenario richtte zich op verschillende niveaus van

samenwerking – nationaal, internationaal en publiek-privaat.

De oefening creëerde een platform waar publieke en private spelers de mogelijkheden van nationale en internationale samenwerking konden verkennen. Deelnemers waren overheidsspecialisten en vertegenwoordigers van landelijke (stroom) netbeheerders – internationaal bekend onder de naam Transport System Operators (TSO's).

Als onderdeel van het project is een handboek opgesteld, waarin stap voor stap staat beschreven hoe een dergelijke bijeenkomst georganiseerd kan worden.

The exercise focused on group discussions in alternating group compositions, within the context of a scenario with a rapidly growing impact. The scenario concerned the need for rotating planned blackouts due to an extremely dry period in Europe. The exercise scenario focused on various levels of cooperation — national, international and public-private.

The exercise created a platform where public and private actors could interact and explore the whole range of national and international cooperation. Participants included representatives of transport system operators and government representatives (critical infrastructure protection, energy policy and crisis management policymakers).

An important product from the project is a hands-on manual on how to organise a VITEX-style exercise on almost any scale.

Projekt zdecydowanie przyczyni się do skutecznego ścigania przestępców, zwłaszcza w przypadku pedofilii, gdyż budowana baza haszy będzie mogła zostać udostępniona innym krajom członkowskim oraz Europolowi. Obecnie niektóre kraje członkowskie UE już takie bazy posiadają, więc wzajemna wymiana rekordów przyczyni się do zwiększenia zasobów istniejących baz i skrócenia czasu analiz nośników cyfrowych.

Zbieranie informacji o plikach związanych z działalnością przestępczą jest aktualnie warunkiem koniecznym do skutecznej współpracy pomiędzy organami ścigania krajów członkowskich i pozwoli nie tylko na wspomniane skrócenie czasu analizy zawartości nośników cyfrowych, ale być może także na skuteczniejsze zwalczanie przestępstw o charakterze międzynarodowym – np. oznaczony plik z działalności grupy przestępczej w Polsce może być przydatny dla identyfikacji działania tej grupy poza granicami, np. na terenie Niemiec, Rumunii itd.

Należy także podkreślić, że zwiększona aktywność organów ścigania krajów członkowskich wpływa znacząco na działalność Europolu, którego jednym z celów jest próba łączenia rozwiązań i metod stosowanych przez kraje członkowskie i udostępnianie ich dalej.

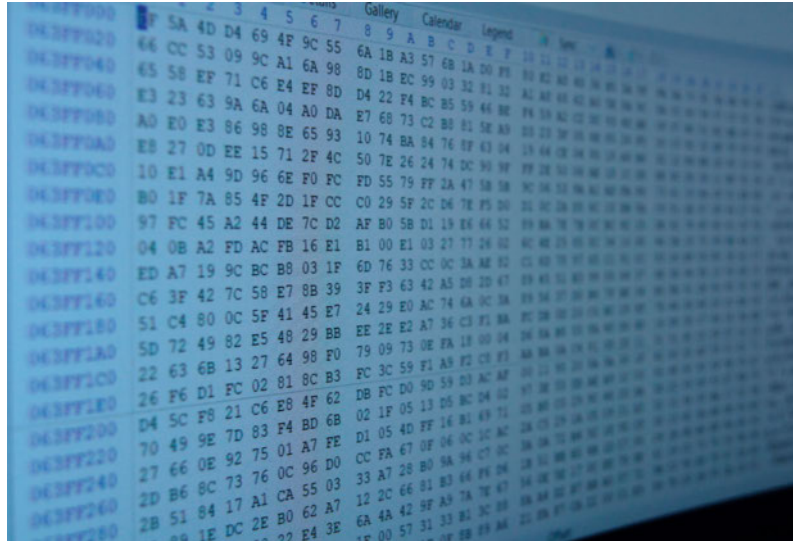

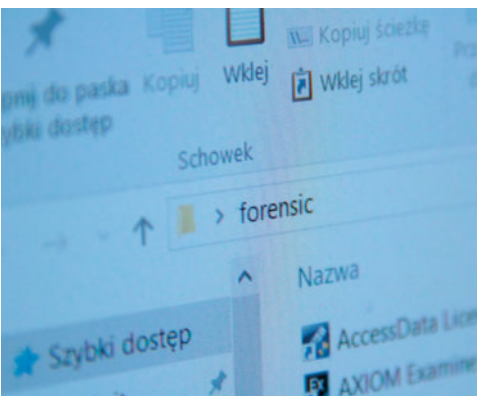


The aim of the project is to build an integrated, central information system containing files related to criminal activities in order to collect intertwined hash files in a special database comprising criminal contents. The database will be used for day-to-day analysis and will enable immediate access to digital criminal contents already present in the database. This will have an impact on significant reduction of work time of crime analysts while increasing their effectiveness by several times. The system will allow to break down cryptographic protection (based on hashes). The project will definitely contribute to more effective prosecution of criminals, especially in the case of pedophile, as

the built hash database could be made available to other EU Member States and Europol. Currently, some of the EU Member States are already in the possession of this database, therefore the mutual exchange of records will increase the capabilities of currently existing databases and will decrease the time for digital media analysis.

The collection of information about hash files linked with criminal activities is actually a sine qua non for effective cooperation with the EU Member States' law enforcement authorities which allow not only for the aforementioned reduction of time needed to analyse the content of digital media, but also, possibly, for more effective international crime combating. For instance, a marked file regarding the activity of an organized crime group in Poland may be useful for the identification of an activity of this group outside its borders, e.g. in Germany or Romania, etc.

It is worth mentioning also that an increased activity of the EU Member States' law enforcement authorities has a significant impact on the activity of Europol, which one of the aims is to try to link solutions and methods applied by EU Member States to make them available further.

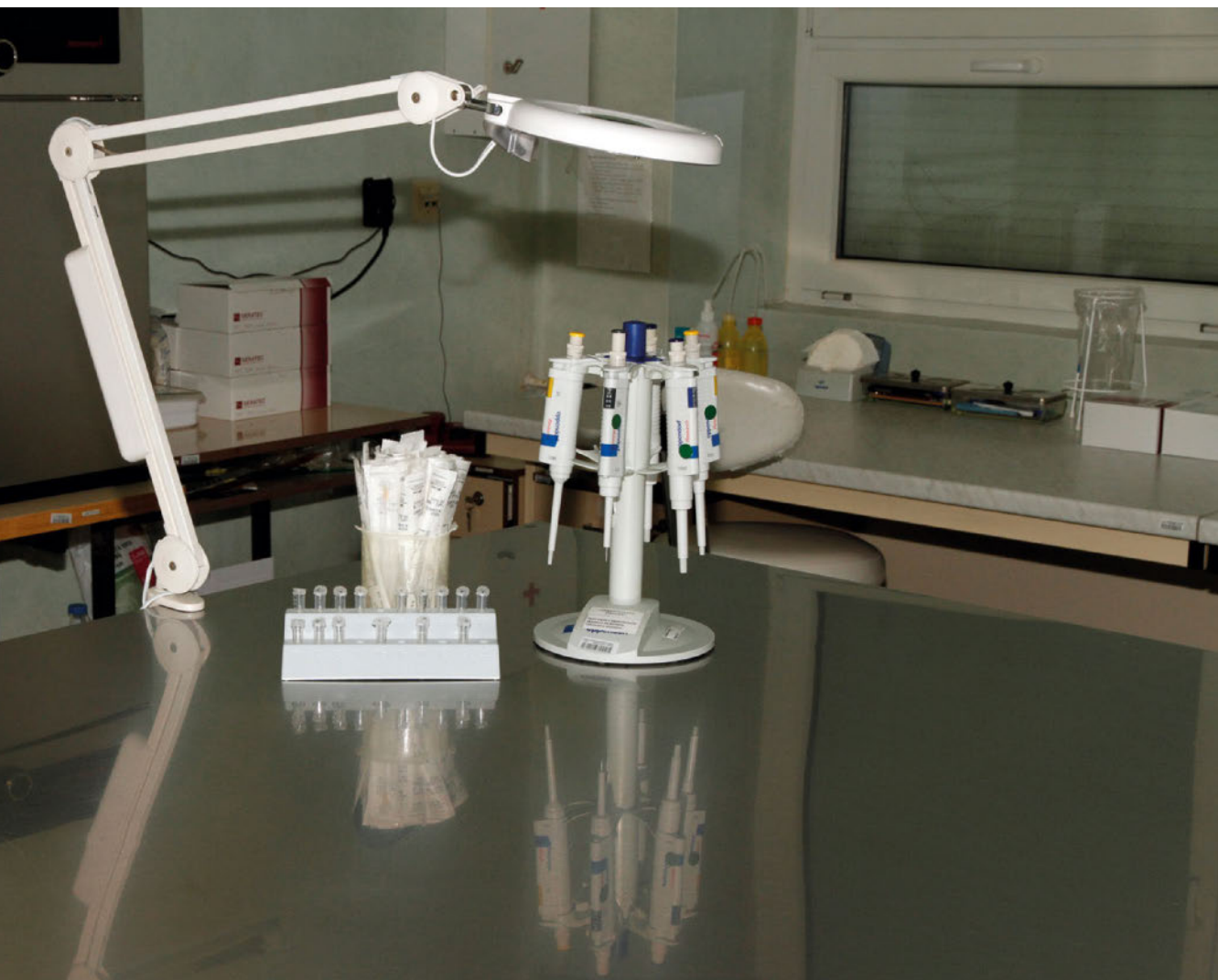

ISF Police Project: Sistema de Registro de Nombre de Pasajeros (PNR) (ES/2016/PR/67)



Una vez publicada la Directiva PNR (“Registro de Nombre de Pasajero”) 2016/681 de 27 de abril de 2016, los Estados Miembros tienen dos años para obligar a las aerolíneas a entregar a las autoridades nacionales los datos de los pasajeros de todos los vuelos llegados a la UE desde terceros países y viceversa para la prevención, detección, investigación y enjuiciamiento de delitos terroristas y otros delitos graves.

Objetivos: Una vez obtenidos los datos de las aerolíneas, el sistema coteja la información del PNR con bases de datos policiales (tales como BDSN –Base de Datos de Señalamientos Nacionales-, SIS –Sistema de Información Schengen-, SICOA –Sistema de Coordinación Antiterrorista-, APIS –Información Avanzada de Pasajeros-, etc.) generando alertas que permitan una mejora en la lucha contra el terrorismo y el crimen organizado.

Actividades: Adquisición de plataformas tecnológicas para la gestión de consultas gene-

radas por el sistema PNR a las bases de datos policiales. Adquisición de las licencias de sistema operativo necesarias para el correcto funcionamiento de los servidores que soportan el sistema PNR. ISF Police project: Passenger Name Record System (PNR) (ES/2016/PR/67)



Key challenge project seeks to address. Once the PNR ("Passenger Name Registration") Directive 2016/681 of 27 April 2016 has been published, Member States have two years to compel airlines to provide passenger data to national authorities of all the flights come to the EU from third countries and vice versa for the prevention, detection, investigation and prosecution of terrorist crimes and other serious crimes.

Objectives. Once the airline data is obtained, the system match the PNR information with police databases (such as BDSN - National Signal Data Database - SIS - Schengen Information System - SICOA - Antiterrorist Coordination System- , APIS - Advanced Information of Passengers, etc.) generating alerts that allow an improvement in the fight against terrorism and organized crime.

Main activities/components of the project. Acquisition of technological platforms for the management of queries generated by the PNR system to the police databases. Acquisition of the operating system licenses necessary for the correct functioning of the servers that support the PNR system. Acquisition of firewall and load balancers to ensure the security and robustness of the system. Contracting a service for a corrective, preventive, and developmental IT maintenance of the PNR System.

Expected results. Acquisition of the necessary equipment to guarantee the security of the communications isolating them of any other system and guaranteeing the connections to the exterior as well as to exploit the functionalities that facilitate the correct operation of the PNR system.

ISF Polis Projekt: Nationell utbildning om brottsutbyte och penningtvätt



Projektet syftar till att höja kompetensnivån inom rättsväsendet kring brottsutbytesfrågor och det nya penningtvättsbrottet. Målet är ökad effektivitet i arbetet med att återföra brottsvinster från kriminella samt att försvåra för kriminella att behålla egendom från brott. Effektivitetsvinsterna innebär rent konkret att egendom från brott säkras under förundersökningen i större utsträckning än idag och att antalet förverkandeyrkanden och yrkanden om skadestånd i samband med åtal samt antalet åtal och fällande domar för penningtvättsbrott ökar.

Projektet består av tre utbildningsinsatser för åklagare och revisorer inom Åklagarmyndigheten och finansiella utredare inom Polismyndigheten:

Internal Security Fund: Borders and Visas

The Internal Security Fund (ISF) was set up for the 2014-2020 period, with a total of EUR 3.8 billion for the 7 years. The fund promotes the implementation of the internal security strategy, *law enforcement cooperation* and *the management of the EU's external borders*. The ISF is composed of two instruments: *ISF Borders and Visa* and *ISF Police*.

ACHIEVING THE KEY OBJECTIVES

The ISF Borders and Visa instrument's main objective is to contribute to ensuring a high level of security in the EU while facilitating legitimate travel. This fund has the following specific objectives.

- **Visas.** The effective processing of Schengen visas by supporting a *common visa policy* to facilitate legitimate travel to the EU, providing a high quality of service to visa applicants, ensuring equal treatment of non-EU nationals and tackling irregular migration.
- **Borders.** Achieving a uniform and high level of control of the external borders by supporting integrated border management, harmonising border management measures within the EU and sharing information among Member States, and between Member States and *Frontex*, to halt irregular migration and ensure the smooth crossing of the external borders.

For the 2014-2020 period EUR 2.76 billion is available for funding actions under the ISF Borders and Visa instrument, of which EUR 1.55 billion is channelled through shared management and EUR 1.06 through direct management. EUR 154 million is reserved for the special transit scheme (Lithuania).

Concrete actions funded include a wide range of initiatives such as setting up and running IT systems, acquiring operational equipment, promoting and developing training schemes and ensuring administrative and operational coordination and cooperation.

THE FUND'S BENEFICIARIES

All Member States except Ireland and the United Kingdom participate in the implementation of the ISF Borders instrument. The four Schengen-associated countries (Iceland, Liechtenstein, Norway and Switzerland) also participate. ISF Grenzen Projekt: Ankauf von drei Wärmebildfahrzeugen für CRATE Pool Frontex (AT/2016/PR/0031)



Zur Verhinderung illegaler Migration und Bekämpfung grenzüberschreitender Kriminalität ist neben der Grenzübertrettskontrolle die Grenzüberwachung ein wesentlicher Erfolgsfaktor. Insbesondere Dunkelheit, schlechte Sicht und schwieriges Gelände erschweren die Feststellung von illegalen Grenzaktivitäten.

Wärmebildkameras helfen, die Anforderungen in der Nacht und anderen schwierigen Sichtbedingungen zu erfüllen.

Wärmebildtechnik ist auch bei Tageslicht hilfreich. Eine Wärmebildkamera kann nicht so durch die Sonne geblendet werden, wie herkömmliche Kameras. Darüber hinaus ist es sehr schwer, thermischen Kontrast zu verschleiern, wodurch versuchtes Tarnen oder Verstecken leichter entdeckt wird.

Der Einsatz von Wärmebildtechnik ermöglicht es dem Bundesministerium für Inneres, einen wertvollen Beitrag im Rahmen von FRONTEX Einsätzen zu leisten und damit den Einsatzwert der grenzpolizeilichen Unterstützungsmaßnahmen in anderen Ländern zu steigern.

ISF Borders project: Acquisition of three thermal-imaging vehicles for the Frontex CRATE pool (AT/2016/PR/0031)

In order to prevent illegal migration and fight against cross-border crime, border surveillance is an essential success factor. In particular, darkness, poor visibility and difficult terrain make it difficult to identify illegal border activities.

Thermal-imaging cameras help to meet the demands at night and in other low-light situations. Thermal imaging is also useful in broad daylight. A thermal-imaging camera cannot be

blinded by the sun like a normal CCTV camera. Furthermore, thermal contrast is extremely difficult to mask so people trying to camouflage themselves or trying to hide will be detected seamlessly.

The use of thermal-imaging technology makes it possible for the Federal Ministry of the Interior to make a valuable contribution within Frontex to increasing the value of cross-border support measures in other countries.

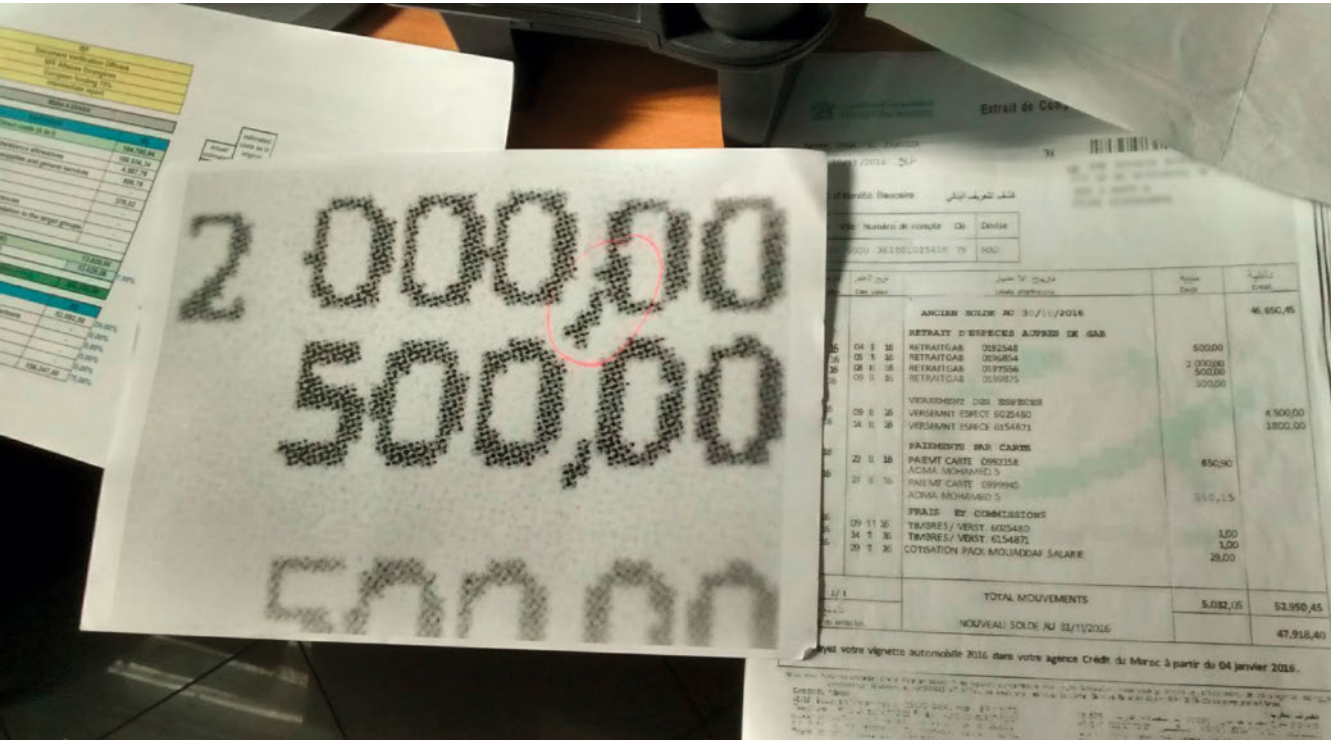

susceptible to fraud. His/her tasks are: verifying documents relating to visa applications; constructing a network in the field; ad hoc verifying of documents upon the demand of the Belgian authorities; and reporting and updating statistics, particularly in relation to Schengen partners.

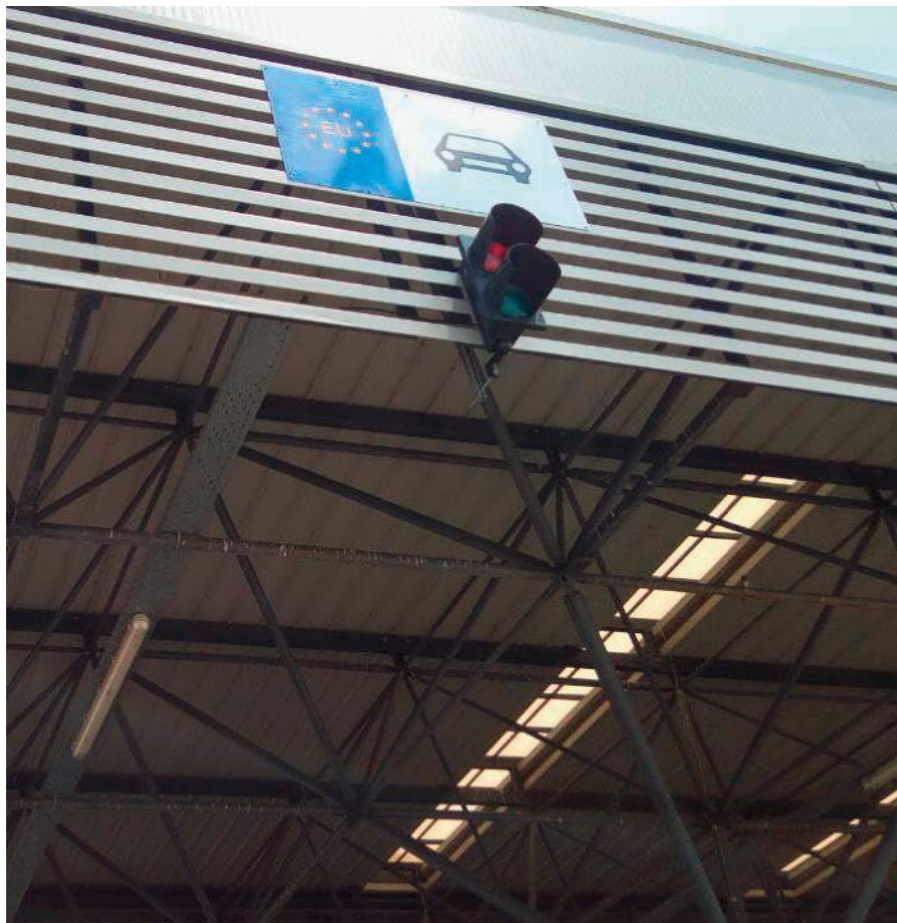

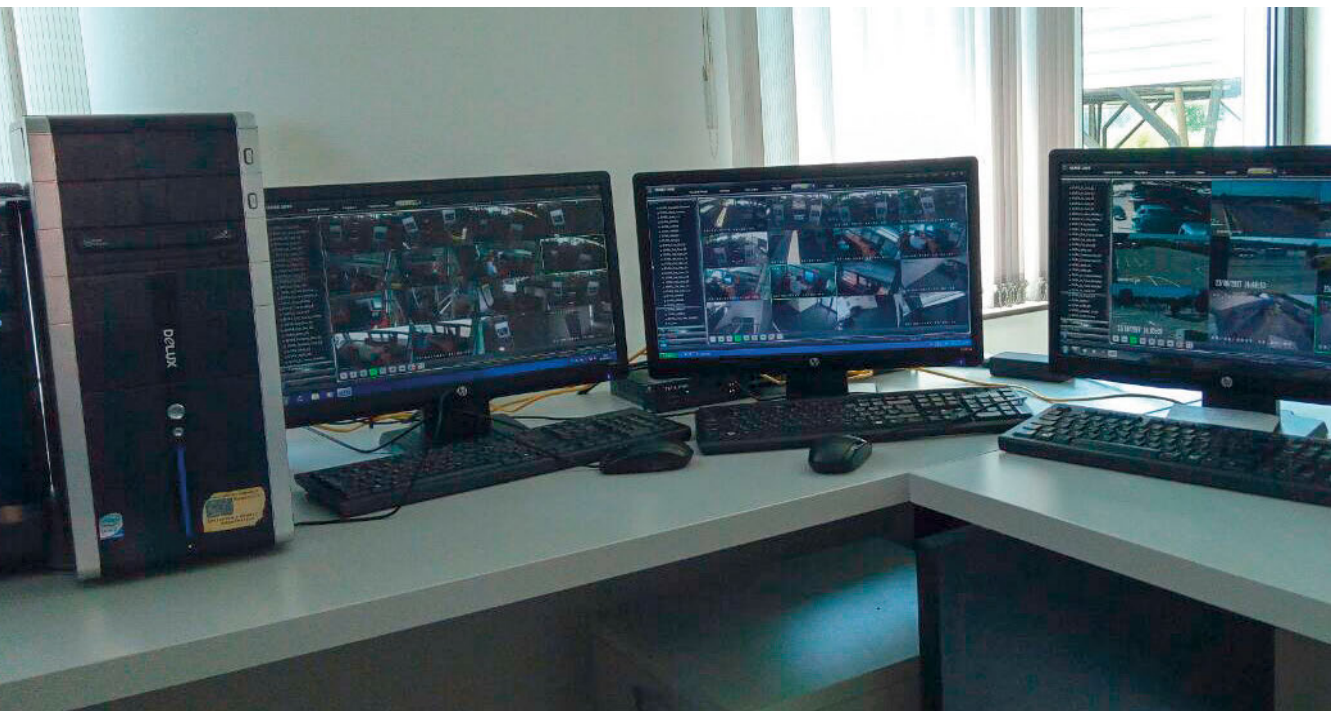

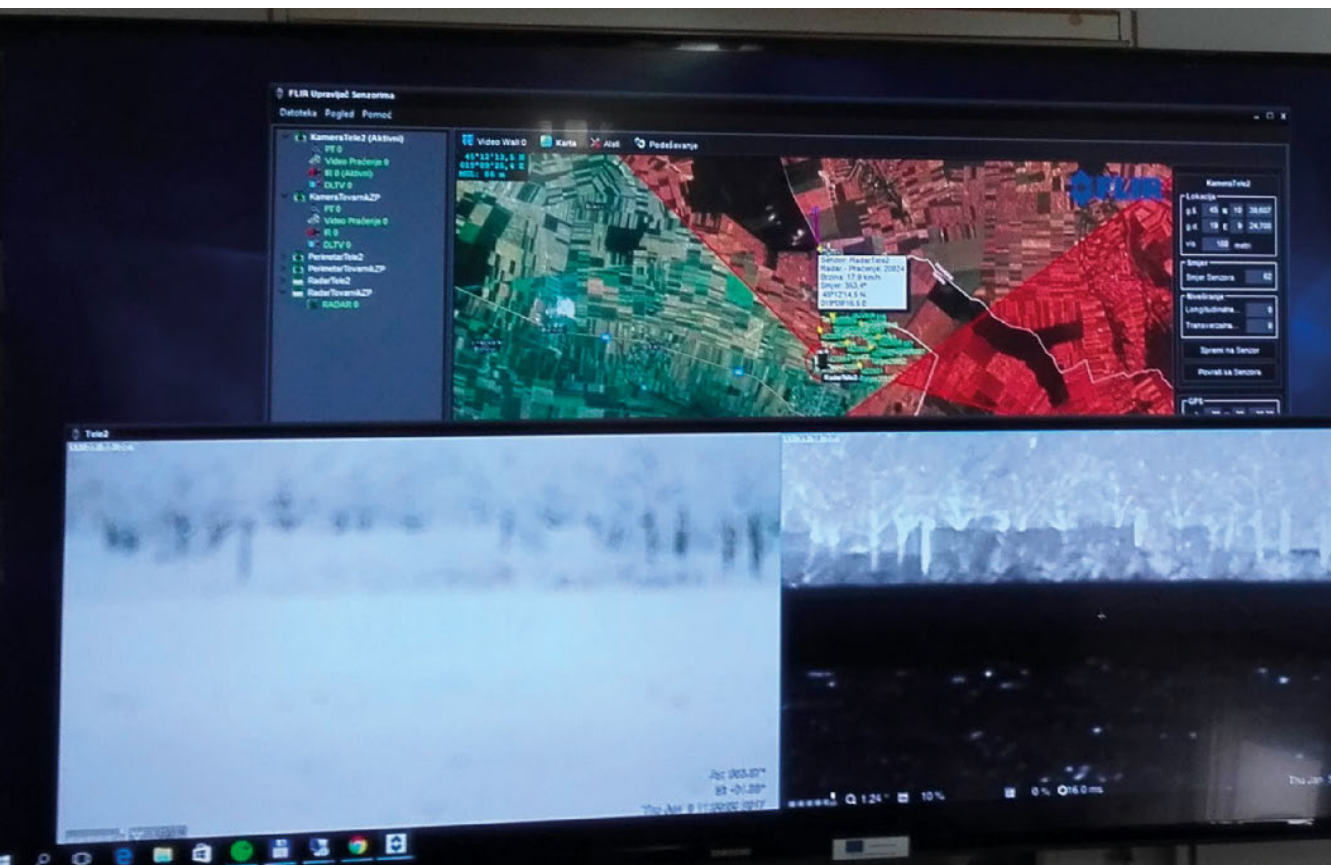

Το Σ.Π.Π στοχεύει στην ενίσχυση της ικανότητας παρατήρησης, εντοπισμού στόχων στις θαλάσσιες περιοχές πλησίον της ακτογραμμής της Κυπριακής Δημοκρατίας και εγρήγορση των αρχών ενόψει έκτακτης κατάστασης.

Η συγχρηματοδότηση του Σ.Π.Π περιλαμβάνει 3 σταθερές, 3 κινητές και 2 εναέριας πλατφόρμες παρατήρησης, (μεγάλης εμβέλειας) και εξειδικευμένο λογισμικό, εγκαταστημένο σε κέντρα ελέγχου. Κάθε πλατφόρμα παρατήρησης εξοπλίστηκε με κάμερες ημέρας/ νύχτας, κάθετα ή οριζόντια μετακινούμενες για βέλτιστη οπτική γωνία, μέσω τηλεχειρισμού από το Κέντρο Συντονισμού Έρευνας και Διάσωσης -(Κ.Σ.Ε.Σ).

Η εγκατάσταση του Σ.Π.Π πολλαπλασίασε τις επιχειρησιακές δυνατότητες του Κ.Σ.Ε.Δ. Αποτέλεσμα, η πιο στοχευμένη έρευνα, ο γρηγορότερος εντοπισμός στόχων και η αυξημένη πιθανότητα διάσωσης. Παράλληλα βελτιώθηκε η επιτήρηση των θαλάσσιων συνόρων, η διαχείριση έκτακτων περιστατικών και τα επίπεδα ασφάλειας στην Κυπριακή Δημοκρατία και στην παρακείμενη ναυσιπλοΐα/θαλάσσιες δραστηριότητες.

ISF Borders project: Coastal surveillance system (CSS) (CY/2016/PR/0005)

The coastal surveillance system (CSS) aims to augment the surveillance and target identification capabilities of Cyprus in territorial waters close to its coastline and to effectively alert the Cypriot authorities during emergency.

The co-funded CSS comprises of three fixed, three mobile and two air-surveillance platforms (long range), along with specialised software installed in control centres operated by the Joint Rescue Coordination Centre (JRCC). Each platform is equipped with colour and thermal cameras, remotely controlled in azimuth and elevation, for optimum observation capability. Installing the CSS has augmented the operational capabilities of JRCC. The result is the immediate investigation of incidents by simply turning the camera to the required coordinates. This gives faster reaction

times and ultimately leads to more lives being saved. Alongside improved surveillance of maritime borders it increases effectively the safety levels of the waterways and maritime activities of Cyprus.

The aim of the project is to create the National Border Situation Centre for Border Control as a joint communication centre for the Directorate of Alien Police and the Customs Administration of the Czech Republic for effective fulfilment of protection and border management tasks.

The main activity of the project is the major reconstruction of premises. The premises will be suitably equipped for operational management with appropriate technology. A data warehouse with the ability to perform advanced and sophisticated analysis will be created. Other IT systems for border control and operation of the centre will be created or upgraded. The centre will be responsible for the operational management of border surveillance and the implementation of operational analysis. It will manage IT

systems for border protection, such as Eurosur, the AGAS airspace surveillance system, the KODOX border control system and the passenger data transfer system. The centre will carry out the tasks of the national control authority in relation to biometric documents.

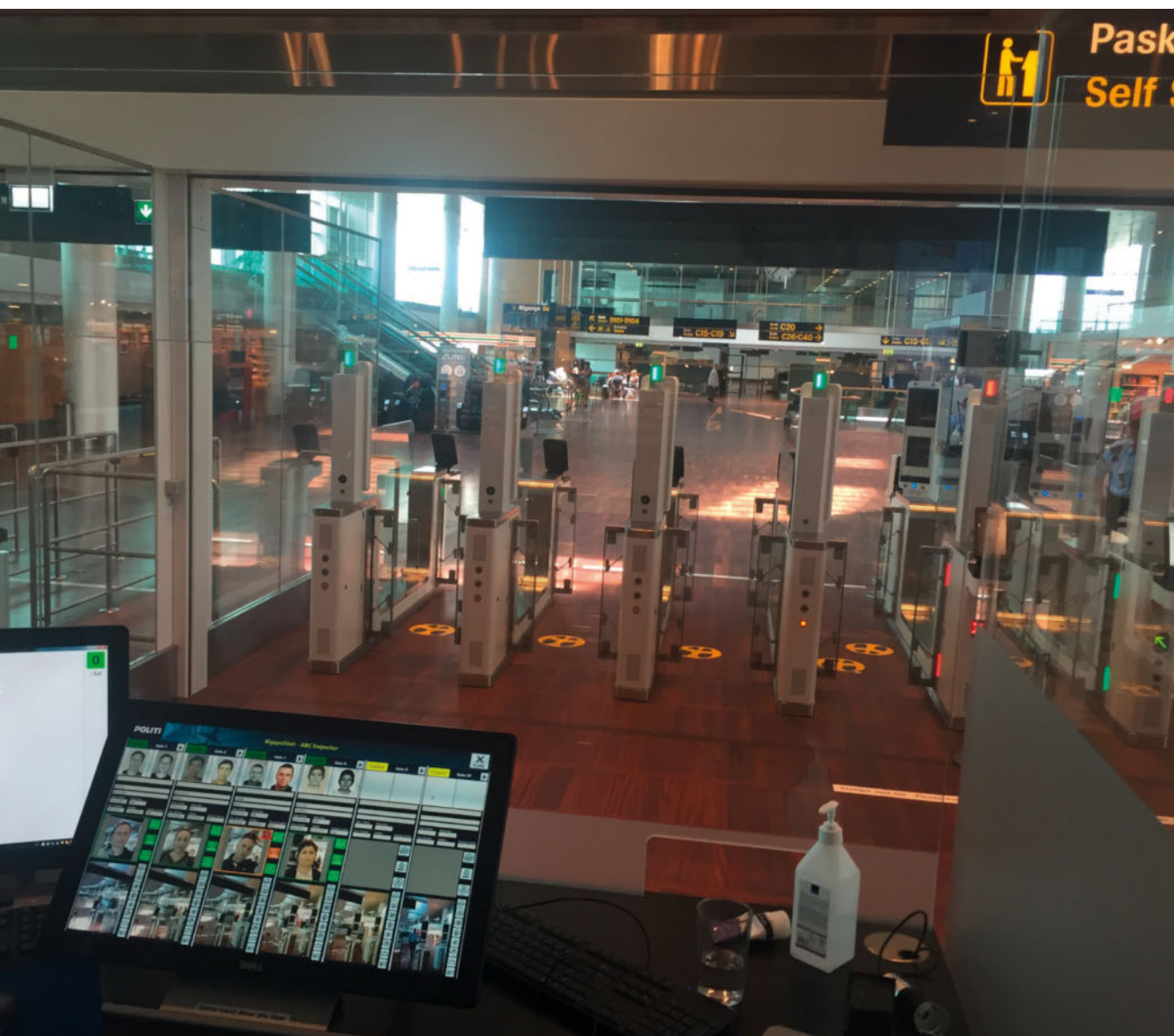
ISF Borders Projekt: Installation af ABC-gates og relaterede omkostninger (2014 DK65ISNP001)

Projektet er en del af et samlet projekt, som blev igangsat under EU's Grænsefond og bl.a. omfattede anskaffelse af 10 ABC eGates med tilhørende software, softwarelicenser, inventar og løsningsmodel til grænsekontrol i Københavns Lufthavn.

Projektet under ISF omfatter restbetaling af de 10 ABC eGates og 1 CCTV-Server anskaffet under fase 1 af projektet; Installation af ABC eGates og 2 ABC eGate overvågningsstationer med tilhørende hardware mv.; etablering af IT-mæssig integration mellem ABC eGate-løsningen og

relevante IT-systemer hos Dansk Politi, eksternt projektledelsesbistand, bygherrerådgivning og anden konsulentbistand; samt diverse øvrige foranstaltninger.

Projektet omkring installation af ABC-gates har styrket kontrolindsatsen i Københavns lufthavn, idet der i forhold til alle, der passerer gennem disse gates, foretages en automatisk søgning i relevante politisystemer (Kriminalregisteret, Pasregisteret, SIS II og Interpols person- og dokumentdatabaser).



ISF Borders project: Installation of automatic border control gates and related costs (2014DK65ISNP001)

The project is part of a joint project that was launched under the External Borders Fund and included the acquisition of 10 automatic border control (ABC) e-gates with associated software, software licences, inventory and border control solutions at Copenhagen Airport.

The project for the installation of the ABC gates has strengthened the control efforts at Copenhagen Airport, as an automatic search is performed in relevant police systems (criminal registry, passport register, SIS II and Interpol person and document databases) on all persons passing through.



The project under the ISF includes the remaining payment for the 10 ABC e-gates and one CCTV server acquired during phase 1 of the project; the installation of ABC e-gates and two ABC e-gate monitoring stations with associated hardware etc.; the establishment of IT integration between the ABC e-gate solution and relevant IT systems at Dansk Politi, external project management assistance, building consultancy and other consultancy assistance; and a range of other necessary measures.

ISF Borders Projekt: Multirootorid välispiiril vaatlustegevuse teostamiseks (EE/2016/PR/0040)



Problem: Eesti Vabariigi välispiiri maastik on väga mitmekesine. Maismaalõigus on suuri soiseid ja künklikke alasid, ning arvestades maastiku eripära, piirdub otsenägevus ca 100 meetriga. Esineb piirkondi, kuhu ei ole võimalik pääseda jalgsi patrullimisega ning igapäevane patrullimine laeva ja muude sõidukitega on väga kulukas, mistõttu on otstarbekam kasutada mehitamata õhusõidukeid, mis võimaldavad piirivahejuhtumeid lahendada kiiremini ja tulemuslikumalt, seda ka öisel ajal.

Eesmärk: Tõsta ebaseaduslike piiriületajate avastamise võimekust ja fikseerimist ning suurendada patrullidel oluliselt parema ülevaate saamist piirilähedasel alal toimuvatest tegevustest. Toetada kiiremat ja kuluefektiivsemat patrullide rakendamist piirivahejuhtumite lahendamisel.

Peamised tegevused:

- hanketaotluse esitamine ja kooskõlastamine hankelepingutalitusega;
- hanke läbiviimine, tulemuste hindamine, välitestid ja võitja väljakuulutamine;
- hankelepingu sõlmimine;
- multirootorite vastavuse kontroll tehnilisele kirjeldusele, vastuvõtmine, kasutajate koolitamine ja lõppkasutajale üleandmine.

Tulemus: Multirootorid on soetatud, antud kordonite käsutusse ja välja on koolitatud personal, kes oskab soetatud seadmeid kasutada. Läbiviidavad otsingud piirivahejuhtumite lahendamisel võtavad vähem aega ja on tulemuslikumad. Tõuseb reageerimistäpsus piirijuhtumitele, eriti öisel ajal. Piirijuhtumite lahendamine ja menetluste läbiviimise kvaliteet paraneb ning lihtsustub piiriveekogudel transpordivahendite tuvastamine.

ISF Borders project: Multirotors for surveillance at the external border (EE/2016/PR/0040)

Challenge. The problem throughout Estonian external border is that the terrain of the land border is very diverse, with large wet and hilly areas. Therefore, taking into account the difficult and diverse landscape features, direct views of and access to some of the areas near the border is very limited. Some areas are impossible for a foot patrol to access. However, carrying out daily patrols by using patrol vessels and other vehicles would be very costly. Thus, it would be rational to use unmanned aerial vehicles that provide the possibility to access rough areas and to solve border incidents faster and more effectively even at night.

Objective. It is important to increase the capability to detect illegal border crossings by improving the overview of the area close to the border and making it possible to access rough areas faster. Another important objective is to support faster and more cost-effective implementation of border patrols in resolving border incidents.

Activities.

- Conducting procurement activities.
- Field tests.
- Evaluating the procurement results and announcing the winner.
- Verifying the technical specifications.
- Receiving multirotors.
- Training users and transferring to the end user.

Results. Multirotors are acquired and provided at the disposal of the cordon. Personnel are trained and capable of using the equipment. Searches conducted by patrols to resolve border incidents take less time and are more effective. Response accuracy rises, especially at night. The quality improves in regard to resolving border incidents and conducting procedures. Waterway transport detection is improved and simplified.

ISF Borders Projekt: KEVAK 2020 - Rajavartiolaitoksen kevytalukskaluston suorituskyky 2020 (FI/2015/PR/1808)



Tarve hankkeelle on syntynyt vanhenevan kevyen aluskaluston myötä, mikä aiheuttaa huomattavia käyttö- ja ylläpitomenoja.

Tavoitteena on kotimaassa ja vuosittain erikseen sovittavalla tavalla Frontex-operaatioissa käytettävän kevyen aluskaluston merellisen suorituskyvyn varmistaminen 2020-luvulla.

ISF-rahaston erityistoimirahtauksella Suomi on hankkinut yhden nopean veneen. Hankkeessa on tehty perusteellisia teknisten ratkaisujen testejä, joiden pohjalta kehitetään lopullinen venesarja. Vene on ilmoitettu Frontexin kalustopooliin.

Näillä kehitettävillä veneillä tullaan suorittamaan merkittävä määrä rajaturvallisuustehtäviä monia vuosia eteenpäin. Venetyypit toimii yhdessä suurempien partioveneidän kanssa merivartioston päivittäisenä perustyökaluna.

Frontex-operaatioissa rajavalvontatehtävät johtavat usein meripelastustehtäviin ja tämän veneen ominaisuudet tulevat esiin vedestä pelastamisen turvallisuutena sekä kokoluokkaan nähden erittäin suurena evakuoitinkapasiteettina.

ISF Borders project: KEVAK 2020 — Finnish border guard light craft performance 2020 (FI/2015/PR/1808)

The project is needed due to the ageing of the lightweight vessel fleet, which is causing considerable usage and maintenance costs.

Objective: to ensure the performance in marine operating conditions of the lightweight marine vessel fleet used in Finland and, on the basis of separate annual agreements, in Frontex operations, in the 2020s.

Activity: as a specific action funded by the ISF Finland has implemented the acquisition of one rapid boat. The project has involved the thorough testing of the technical solutions on which the final boat series will be based. The boat has been entered into Frontex's technical equipment pool.

Results: the boats to be developed will be used in a significant number of border security tasks for many years to come. This boat type will be a basic daily tool for the coast guard station alongside bigger patrol boats.

In Frontex operations, border control operations often lead to rescue missions at sea, and the properties of this boat make maritime rescue operations safer and, for a boat of its size, it has an extremely high evacuation capacity.



ISF Frontière projet: Local de délivrance de visas à la frontière (FR/2014/PR/0189)



Ce projet a permis la création de 8 locaux délivrant des visas biométriques dans les 4 terminaux de l'aéroport Roissy-Charles de Gaulle. Le visa est normalement délivré dans un poste consulaire préalablement au voyage. Le local permet de délivrer un visa directement à la frontière, c'est-à-dire dans l'aéroport, à des personnes n'ayant pas pu en faire la demande avant d'arriver en France (raisons médicales, changement de cap d'avion, motifs professionnels...).

Ces locaux sont pratiques pour les usagers car ils permettent la délivrance d'un visa en une vingtaine de minutes, dans un local privé assurant la discrétion. Les locaux ont été équipés afin d'alimenter la base de données du Système d'information visas (VIS). Cela permet donc le partage d'information avec les partenaires européens. En plus de conditions de travail améliorées, le local permet un traitement plus sécurisé de la demande grâce à la prise d'empreintes et la consultation de différentes bases de données européennes.



ISF Borders project: Premises for issuing visas at the border (FR/2014/PR/0189)

This project enabled the creation of eight premises for issuing biometric visas in the four terminals of the Roissy-Charles de Gaulle airport. Usually, visas are delivered in a consular post. These premises therefore enable visas to be issued directly at the border, i.e. in the airport, to people who could not apply for a visa before arriving in France (for medical reasons, a change to the aircraft's course, urgent professional reasons, etc.).

These premises are practical for users because they allow visas to be issued in about 20 minutes, in a private space that ensures confidentiality. The premises have been equipped to provide the visa information system with information to allow the sharing of information with European partners. In addition to better working conditions, the premises allow more secure processing of the visa application thanks to fingerprinting and the querying of the several European databases.

ISF Grenz projekt: Automatisiertes Grenzkontrollsystem — EasyPASS (DE/2015/PR/1521)

Das wichtigste Herausforderungsprojekt sucht:

Mit dem Projekt EasyPASS soll ein automatisiertes Grenzkontrollverfahren für EU/ EWR/ CH-Staatsangehörige mit ePässen eingeführt werden, das einen wesentlichen höheren Durchsatz bietet, als die manuelle Kontrolle. Ein Registrierungsprozess hierfür sollte nicht erforderlich sein.

Ziele: Ein flächendeckender Einsatz an allen zugelassenen Grenzübergangsstellen war aus wirtschaftlichen Gesichtspunkten nicht Planungsgrundlage. Vielmehr wurden durch statistische Erhebungen die Passagierstärksten Flughäfen und deren Bedarf ermittelt. Somit bestand ein Bedarf von 200 eGates an 6 Flughäfen.

Hauptaktivitäten:

- Beschaffung des Grundsystems EasyPASS
- Einbau- und Umbaumaßnahmen an den Flughäfen

- Systemeinführung
- Systempflege
(Wartungsmaßnahmen)

Ergebnisse: In der Projektlaufzeit wurden insgesamt 32 EasyPASS Gates beschafft und an den Flughäfen aufgebaut und in Betrieb genommen. Die eGates stehen den Reisenden in Frankfurt/Main, München, Düsseldorf, Köln und in Berlin-Tegel zur Ein- und Ausreise zur Verfügung.

Was macht dieses Projekt besonders interessant:

Das System wurde an den Passagierstärksten Flughäfen in Deutschland eingeführt und durch die Reisenden sehr positive angenommen. Durch den Betrieb der EasyPASS Gates konnte Personal, welches im Bereich der Kontrolle von EU-Bürgern eingesetzt war, für die eingehende Kontrolle von Drittstaatsangehörigen gewonnen werde.



ISF Borders project: Automated border control system — EasyPASS (DE/2015/PR/1521)

Key challenge project seeks to address. With the project EasyPASS an automated border control procedure for EU/EEA/Swiss citizens should be established. The passenger flow-rate should be higher than for manual control. A registration process is not necessary.

Objectives. The procurement of the system for all authorised border crossing points was not the basis of the plan; rather, EasyPASS was implemented for economic reasons. A special economic study (cost-benefit analysis) for the project identified a requirement for 200 e-gates at the six most frequented airports.

Main activities/components of the project. Procurement of the basis system EasyPASS; installation and modification measures at the airports; system implementation; and maintenance and support of the system.

Results. Within the project period 32 EasyPASS gates were procured, installed at the airports and put into operation. The e-gates are available for

What makes this project particularly interesting? The system is implemented at the most frequented airports in Germany and is positively accepted by both travellers and border guards. EasyPASS opens up the possibility for border guards to concentrate more on thorough checks of third-country nationals, because the system conducts the minimum checks of EU citizens as provided for in the Schengen Borders Code.

ISF Borders Program: Nagyhódos közúti határátkelőhely tervezése és kivitelezése (HU/2017/PR/0002)

Közúti határátkelőhely létesítése Nagyhódoson, amely a helyi lakosok mindennapjait megkönnyíti, hiszen egyszerűbbé és gyorsabbá teszi a csengeri és a garbolci kistérség lakossága és a vele szemközti ukrán terület lakosságának kapcsolattartását. A projekt hatásaként az ukrán határszakaszon lévő határátkelőhelyek kihasználtsága arányosabbá válik, és a szomszédos határátkelőhelyek tehermentesítéséhez is hoz-

zájárul a létesítés, hiszen alternatív útvonalat biztosít az utazó közönség számára. Az új határátkelőhely létesítése az ukrán határszakaszon lévő Tiszabecs-Tiszaújlak közúti határátkelőhely személy és járműforgalmát is enyhíti. Establishing and opening the Nagyhódos road border crossing point may facilitate daily life for local residents; it will make communication easier and faster between the population of Csenger, Garabolc sub-region and the population of the nearby Ukrainian areas. The effect of the project is that the use of crossing points on the Ukrainian border will become more proportionate and the establishment will contribute to the relieving the related border crossing points because it ensures an alternative route for travellers. The establishment of the new border crossing point will reduce traffic (people, vehicles) at the road border crossing point at the Tiszabecs–Tiszaújlak border with Ukraine.

This solution is based on the latest experience with the German e-gate system EasyPASS, which is the latest result of the EU seventh framework programme project FastPASS.

Key challenge project seeks to address. Be able to manage the ever-increasing passenger numbers; integrate the e-gate solution into the existing infrastructure; be ready for future evolutions of the airport; integrate the e-gate into the architecture of the airport; ensure the adaptability of the solution.

Objectives. Enable border control processes to be carried out quickly and securely; do away with unnecessarily long queues and passenger frustra-

tion; optimise the throughput through the gates; enable implementation of the future projects like RTP (registered travel passengers), EES (entry exit system), etc.

Main activities/components of the project. The integrated two-step process of the e-gates will be used. The e-document will be verified before the passenger enters the e-gate. Inside the e-gate the passenger will be checked by capturing his/her face and matching biometrically the live image against the image stored on the passport's chip. The metadata of the passenger are checked against different databases (SIS II, Interpol, national police database for wanted persons and lost and stolen documents). The e-gates are envisaged for passengers from EU/EEA/Switzerland, over 18 years old and in possession of an e passport.

ISF Borders project: Strengthening the border control capabilities of the Armed Forces of Malta — procurement of a third twin-engine helicopter. (MT/2016/ISF/2.02)



The procurement of a third helicopter will enable the Armed Forces of Malta to ensure a higher level of security on the southernmost borders of Europe, which in turn is an ISF general objective. The continuous operations on the borders will aid in combating organised crime, especially human trafficking, and boost law enforcement at sea. Contributing to this effect, the ISF would enhance the Member States' capacity to effectively manage security-related risks and crises.

The Armed Forces of Malta aim to bolster the command and control of their border activities by having overall operational command of the areas for which they are responsible. These aircraft will also enable Malta to address the shortage of pilots and pilot training with additional flight time.

ISF Borders project: Informatie Ondersteund Beslissen KVV (NL/2015/PR/2015ISFG1/)

Met financiële steun van het ISF ontwikkelt het Ministerie van Buitenlandse Zaken (BZ) een nieuwe werkwijze, het *Informatie Ondersteund Beslissen*.

Het Informatie Ondersteund Beslissen werkt op basis van een vergelijking van gegevens van aanvrager en referent uit de visumaanvraag met informatie die is opgenomen in een speciaal ingerichte database, de Buitenlandse Zaken Analyse Omgeving (BAO). Hierin zit objectieve informatie van Nederlandse

overheidsorganisaties en ambassades. Mede op basis van deze vergelijking, de zogenaamde BAO-check, en het daaraan verbonden advies beslist de consulaire medewerker op een aanvraag. Met deze nieuwe werkwijze wil BZ het proces van besluitvorming rond het verstrekken van Schengenvisa verbeteren. De doelstelling hierbij is het optimaal faciliteren van bonafide reizigers door de wachttijden te verkorten, en het tegengaan van illegale migratie door malafide reizigers effectiever te weren.



ISF Borders project: Information-based decision-making for short-stay visas (NL/2015/PR/2015ISFG1)

With financial support from the EU's Internal Security Fund, the Ministry of Foreign Affairs is developing a new visa assessment method called **information-based decision-making**.

Information-based decision-making works by comparing information provided by visa applicants and sponsors with information held in a specially created database: the Foreign Affairs Application Assessment Database (BAO). This database holds objective information from Dutch government agencies and embassies. The comparison, known as the 'BAO check', and resulting advice helps consular officers to make a decision. This new method allows the Ministry of Foreign Affairs to improve the process of decision-making for Schengen visa applications. The goal is to optimally assist bona fide travellers by reducing processing time and to prevent the illegal migration of potentially malicious applicants in a more effective way.

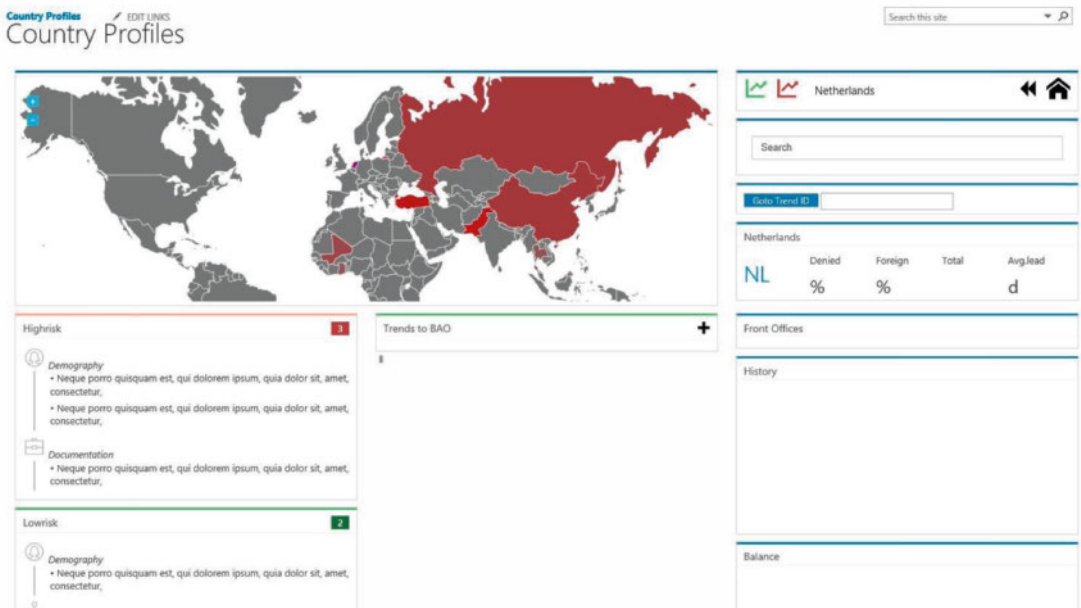

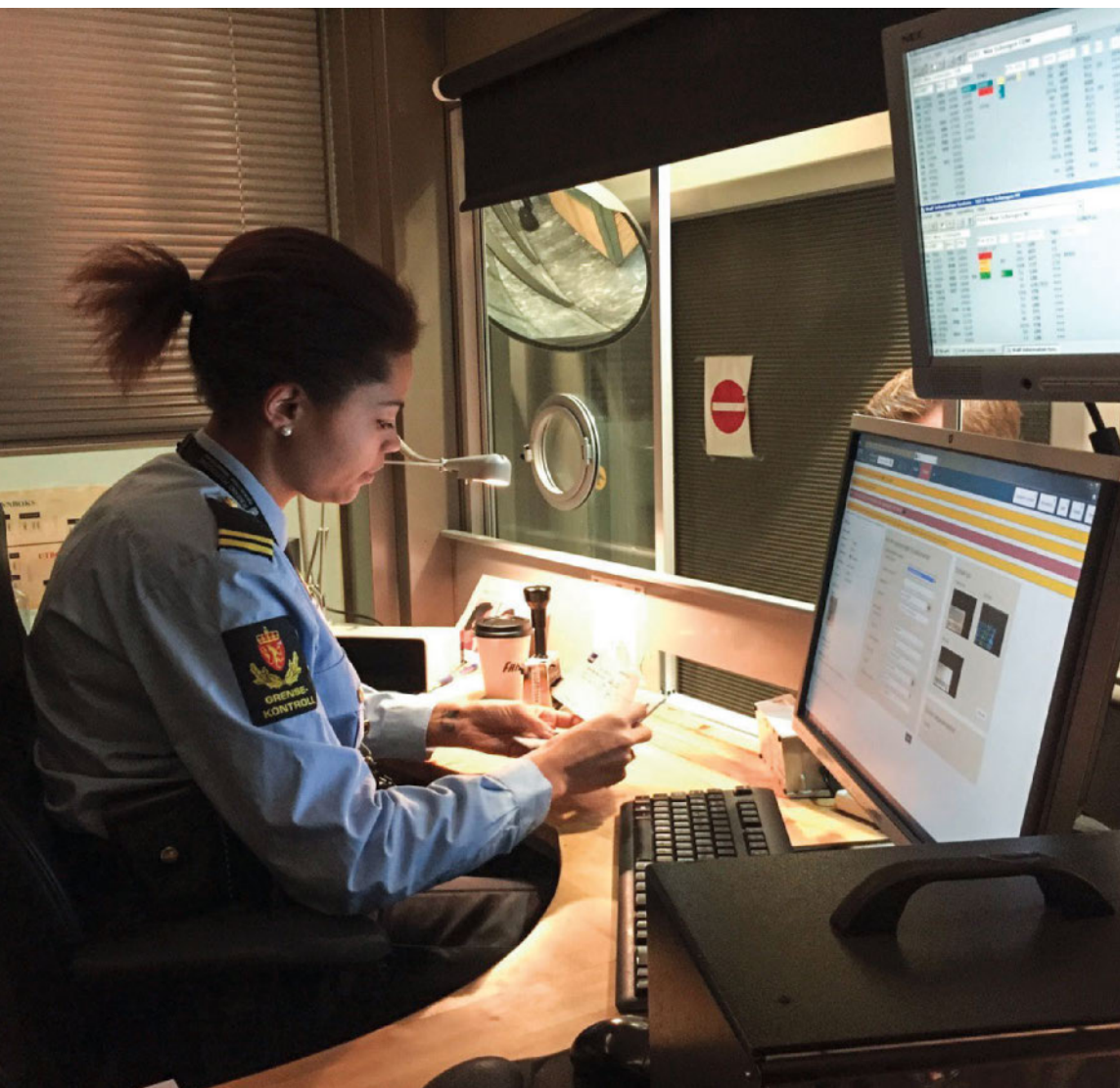

In terms of specific objective No 2: Borders — specific action (Frontex equipment), it is planned that the Polish border guard will purchase two multiengine turbine (fixed wing) aeroplanes that will cooperate in joint operations coordinated by

Frontex and will be used for protection of the eastern Polish border (EU external borders).

It is planned that the purchased (fixed wing) aircraft will have additional equipment such as long-range EO/IR sensors, a mission management system, an external communication system, a maritime surveillance radar and marine survival equipment.

The purchase of further multiengine turbine aeroplanes (M28 Skytruck class or similar) will allow more participation by the Polish border guard in joint Mediterranean operations, thus increasing the operational capabilities of the air component for participation in tasks coordinated by Frontex.

They are well equipped, functional, designed to work in harsh conditions and enable safe and fast navigation.

ISF Borders Project: Advanced Passenger Information System (APIS) (ES/2014/PR/40)

Key challenge project seeks to address. The APIS system allows a comprehensive control of foreign passengers coming from third countries, applied to passenger trips from non-Schengen territory. It identifies candidates to be checked for having an alert in BSSN (National Signals Database) or SIS (Schengen Information Systems). For the proper functioning of the APIS system it is necessary to have the IIR (Informatic Identity Resolution) tool that facilitates the optimized and efficient search of identities, thus allowing an improvement in the ratio of real positives.

Objectives. To provide information on the identification of all passengers arriving in Spain from third countries outside the Schengen area, ensuring an effective fight against illegal immigration, organized international crime by progressively automating all border controls.

Main activities/components of the project. Support and maintenance for IIR ("Informatic Identity Resolution") software licenses for optimized and efficient identity search that allows searching and comparing identity data from more than 60 countries.

Expected results. Enabling functionalities for normalizing data from airlines, improved safety and

detection of criminals at the entrance of passengers in Spain, reduction of the need for resources for the analysis of data from airlines, reduction in the number of false positives and adaptation of the IIR tool, in accordance with the European Directive 2010/65 / EU, for the implementation of the Spanish National Single Port Window.

What makes this project particularly interesting? Selection of candidates for border control based on alerts, which allows to avoid the systematic control of all passengers entering the national territory, especially EU nationals.

ISF Borders project: ABC-Gates für den Flughafen Zürich

Gegenstand des Projektes ist die Einführung von automatisierten Grenzkontrollschleusen (ABC-Gates) für die Ein- und Ausreise an den Schengen-Grenzübergängen am Flughafen Zürich.

Ziel ist es, die steigenden Passagierströme zukünftig effizienter und einfacher abwickeln zu können und dabei die Sicherheit auf höchster Stufe zu erhalten. 2016 verzeichnete der Flughafen Zürich 27,7 Mio. neuer Technologien unterstützt werden, um zu einem höheren Schutz der Schengen-Aussengrenzen beizutragen und die illegale Migration zu bekämpfen.

Sofern sich dieses Pilotprojekt am Flughafen Zürich als erfolgreich erweist, ist der Einsatz von ABC-Gates auch an weiteren Flughäfen in der Schweiz - z.B. am Flughafen Genf - geplant.

Die Teilnahme der Schweiz am ISF-Grenze und somit die Kofinanzierung dieses Projektes bedarf noch der Zustimmung des Schweizer Parlamentes.



ISF Borders project: ABC-Gates for the Zurich Airport

The aim of the project is to install Automated Border Control Gates (ABC-Gates) at the entry and exit Schengen border crossings at Zurich airport. With the rising number of passengers, the goal is to improve the efficiency and convenience of passport controls while ensuring that security remains at the highest level. In 2016 Zurich Airport registered 27.7 million passengers, 11.4 million (41 %) of that were Schengen border crossings. A further increase is to be expected.

Thus, the current border controls shall be supported by introducing new technologies to enhance the protection of the Schengen external borders and help to lower the number of illegal entries.
