THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU) 2021/1147 of the European Parliament and of the Council of 7 July 2021 establishing the Asylum, Migration and Integration Fund¹, and in particular point (a) of Article 13(1) thereof,

Whereas:

- (1) In order to set out an appropriate financial framework for the Asylum, Migration and Integration Fund, it is necessary to set out the annual initial allocations for Member States' programmes calculated on the basis of the criteria laid down in Annex I to Regulation (EU) 2021/1147 in order to allow Member States prepare their programmes in accordance with the article 16 of the Regulation (EU) 2021/1147 and in accordance with the available resources.
- (2) With regard to the transfer of resources referred to in Article 26 of the Common Provisions Regulation (EU) 2021/1060, the initial allocations for Member States' programmes, as set out in this Decision, serve as the basis for calculating any transfers to or from the Asylum, Migration and Integration Fund.
- (3) To facilitate programming by the Member States, the specific annual breakdowns should be given in current prices to reflect a fixed deflator of 2% per year in accordance with the method applied in the Article 4(2) of the Council Regulation (EU, Euratom) 2020/2093².
- (4) In accordance with Articles 1 and 2 of Protocol No 21 on the position of the United Kingdom and Ireland in respect of the area of freedom, security and justice, annexed to the Treaty on European Union and to the Treaty on the Functioning of the European Union, Ireland notified, by letter of 7 February 2022, its wish to take part in the adoption and application of Regulation (EU) 2021/1147. Ireland is therefore bound by this Decision.
- (5) In accordance with Articles 1 and 2 of Protocol No 22 on the position of Denmark, annexed to the Treaty on European Union and to the Treaty on the Functioning of the European Union, Denmark did not take part in the adoption of Regulation (EU)

2021/1147 and is not bound by it or subject to its application. Denmark is therefore not bound by this Decision or subject to its application,

HAS ADOPTED THIS DECISION

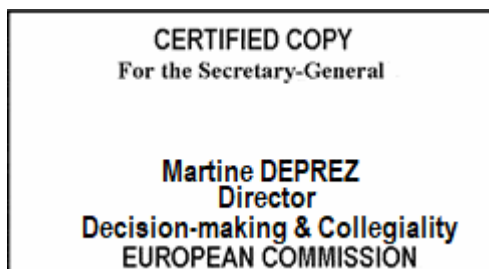

THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU) 2021/1148 of the European Parliament and of the Council of 7 July 2021 establishing, as part of the Integrated Border Management Fund, the Instrument for Financial Support for Border Management and Visa Policy¹, and in particular point (a) of Article 10(1) thereof,

Whereas:

- (1) In order to set out an appropriate financial framework for the Instrument for Financial Support for Border Management and Visa Policy, it is necessary to set out the annual initial allocations for Member States' programmes calculated on the basis of the criteria laid down in Annex I to Regulation (EU) 2021/1148.
- (2) With regard to the transfer of resources referred to in Article 26 of the Common Provisions Regulation (EU) 2021/1060, the initial allocations for Member States' programmes, as set out in this Decision, serve as the basis for calculating any transfers to or from the Instrument for Financial Support for Border Management and Visa Policy.
- (3) To facilitate programming by the Member States, the specific annual breakdowns should be given in current prices to reflect a fixed deflator of 2% per year in accordance with the method applied in the Article 4(2) of the Council Regulation (EU, Euratom) 2020/2093².
- (4) This Decision falls outside the scope of the measures provided for in Council Decision 2002/192/EC³. Regulation (EU) 2021/1148 constitutes a development of the provisions of the Schengen *acquis* in which Ireland does not take part. Ireland is therefore not taking part in the adoption of this Decision and is not bound by it or subject to its application.
- (5) Given that Regulation (EU) 2021/1148 builds upon the Schengen *acquis*, in accordance with Article 4 of Protocol No 22 on the position of Denmark, annexed to

the Treaty on European Union and to the Treaty on the Functioning of the European Union, Denmark notified the implementation of Regulation (EU) 2021/1148 in its national law. Denmark is therefore bound by this Decision.

- (6) As regards Iceland and Norway, this Decision constitutes a development of the provisions of the Schengen *acquis* within the meaning of the Agreement concluded by the Council of the European Union and the Republic of Iceland and the Kingdom of Norway concerning the association of Iceland and Norway with the implementation, application and development of the Schengen *acquis*⁴ which fall within the area referred to in Article 1, points A and B of Council Decision 1999/437/EC⁵.
- (7) However, pursuant to Article 7(6) of Regulation (EU) 2021/1148, participation of Iceland and Norway in the Instrument for Financial Support for Border Management and Visa Policy requires arrangements to specify the nature and modes of such participation in accordance with the relevant provisions of their respective association agreements. This Decision does not apply to Iceland and Norway, because such arrangements have not yet been concluded.
- (8) As regards Switzerland, this Decision constitutes a development of provisions of the Schengen *acquis* within the meaning of the Agreement between the European Union, the European Community and the Swiss Confederation on the Swiss Confederation's association with the implementation, application and development of the Schengen *acquis*⁶ which fall within the area referred to in Article 1, points A and B of Decision 1999/437/EC read in conjunction with Article 3 of Council Decision 2008/146/EC⁷.
- (9) However, pursuant to Article 7(6) of Regulation (EU) 2021/1148, participation of Switzerland in the Instrument for Financial Support for Border Management and Visa Policy requires arrangements to specify the nature and modes of such participation in accordance with the relevant provisions of their respective association agreements. This Decision does not apply to Switzerland, because such arrangements have not yet been concluded.
- (10) As regards Liechtenstein, this Decision constitutes a development of the provisions of the Schengen *acquis* within the meaning of the Protocol between the European Union, the European Community, the Swiss Confederation and the Principality of Liechtenstein on the accession of the Principality of Liechtenstein to the Agreement between the European Union, the European Community and the Swiss Confederation on the Swiss Confederation's association with the implementation, application and development of the Schengen *acquis*⁸ which fall within the area referred to in Article 1, points A and B of Decision 1999/437/EC read in conjunction with Article 3 of Council Decision 2011/350/EU⁹.

- (11) However, pursuant to Article 7(6) of Regulation (EU) 2021/1148, participation of Liechtenstein in the Instrument for Financial Support for Border Management and Visa Policy requires arrangements to specify the nature and modes of such participation in accordance with the relevant provisions of their respective association agreements. This Decision does not apply to Liechtenstein, because such arrangements have not yet been concluded.
- (12) The Schengen Associated Countries have notified their decision to accept the content of the Instrument and to implement it in their internal legal order. The Council authorised the Commission to start the negotiations on the arrangements with the Schengen Associated Countries on 21 February¹⁰. Those countries are to receive their entire initial allocation over the years 2021-2027 regardless of when these arrangements enter into force. In line with sound financial management and transparency, it is therefore necessary to provide for a reserve in the annual initial allocations for Member States' programmes, corresponding to the allocations that the Schengen Associated Countries are entitled to under Annex I to Regulation (EU) 2021/1148,

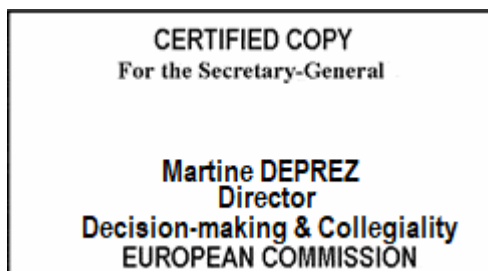

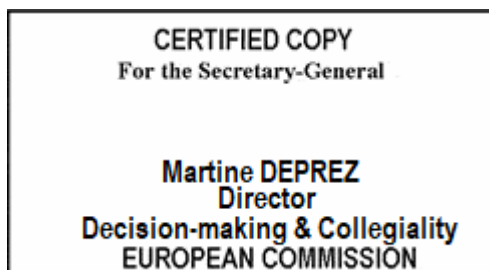
