When reports come in, it checks whether any laws have been violated and then takes further action and cooperates with local police and the Federal Criminal Office in Germany. In addition, it reports to the platform operator criminal entries that constitute hate speech, insult, slander or defamation and demands their deletion. It also offers consultation for victims and reporters.</p>

So we started cooperating with the state criminal office and the state public prosecutor of Baden-Württemberg.</p> <p>We received the evaluation of the criminal office that 91 % of our legal proceedings in 2021 were correct and successful.</p> <p>Since February 2022 we are in a direct cooperation with the federal criminal office and getting reports from all states in Germany.
