To date EU Member States have contributed less than €90 million to the EU-Africa Trust Fund. They should contribute much more substantially to complement the €2.6 billion contribution from the EU's limited budget, and to live up to their commitments dating back to November 2015.

The North Africa window of the EU-Africa Trust Fund

The North Africa window of the EU-Africa Trust Fund is particularly lacking in funds, despite this being one of the most important for reducing flows along the Central Mediterranean Route.

Both the EU and the Member States need to do more to fund the North Africa window of the Trust Fund to ensure its sustainability over time.
