THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU, Euratom) 2018/1046 of the European Parliament and of the Council of 18 July 2018 on the financial rules applicable to the general budget of the Union, amending Regulations (EU) No 1296/2013, (EU) No 1301/2013, (EU) No 1303/2013, (EU) No 1304/2013, (EU) No 1309/2013, (EU) No 13163/2013, (EU) No 223/2014, (EU) No 283/2014, and Decision No 541/2014 and repealing Regulation (EU, Euratom) No 966/2012<sup>1</sup>, and in particular Article 110 thereof,

Having regard to Regulation (EU) No 514/2014<sup>2</sup> of the European Parliament and of the Council of 16 April 2014 laying down general provisions on the Asylum, Migration and Integration Fund and on the instrument for financial support for police cooperation, preventing and combating crime, and crisis management, and in particular Articles 6 to 8 thereof,

Having regard to Regulation (EU) No 513/2014<sup>3</sup> of the European Parliament and of the Council of 16 April 2014 establishing, as part of the Internal Security Fund, the instrument for financial support for police cooperation, preventing and combating crime, and crisis management and repealing Council Decision 2007/125/JHA, and in particular Articles 5(4) and 8 and 10 thereof,

Whereas:

- (1) In order to ensure implementation of Union actions and emergency assistance, it is necessary to adopt an annual financing decision, which constitutes the annual work programme for 2018. Article 110 of Regulation (EU, Euratom) 2018/1046 ('the Financial Regulation') establishes detailed rules on financing decisions.
- (2) It is necessary to allow for the payment of interest due for late payment on the basis of Article 116(5) of the Financial Regulation.
- (3) It is appropriate to authorise award of grants without a call for proposals to the bodies identified in the work programme and for the reasons provided therein.
- (4) Ireland is bound by the application of Regulation (EU) No 513/2014 and as a consequence is taking part in the adoption of this Decision and is subject to its application.

- (5) United Kingdom and Denmark are not bound by Regulation (EU) No 513/2014, or subject to its application and in consequence they are not taking part in the adoption of this decision and are not bound by it or subject to its application.
- (6) The measures provided for in this Decision are in accordance with the opinion of the 'Asylum, Migration and Integration and Internal Security Funds' Committee established by Article 59(1) of Regulation (EU) No 514/2014,

HAS DECIDED AS FOLLOWS:

*Article 1*  
*The Work programme*

The annual financing decision, constituting the annual work programme for 2018 for the implementation of Union actions and emergency assistance in the framework of the Internal Security Fund –Police-, as set out in the Annex, is adopted.

*Article 2*  
*Union Contribution*

The maximum Union contribution for the implementation of the annual work programme for 2018 for Union actions and emergency assistance in the framework of the Internal Security Fund – Police cooperation and crime prevention is set at EUR 70 190 306 and shall be financed from the appropriations entered in the following lines of the general budget for the Union for 2018:

Budget line 18 02 01 02: EUR 70 190 306

The appropriations provided for in the first paragraph may also cover interest due for late payment.

*Article 3*  
*Flexibility Clause*

Cumulated changes to the allocations to actions under this work programme not exceeding 20% of the maximum amount set in Article 2 of this Decision shall not be considered to be substantial for the purposes of Article 110(5) of the Financial Regulation, where those changes do not significantly affect the nature of the actions and objective of the work programme. The increase of the maximum amount set in Article 2 of this Decision shall not exceed 20%.

In implementing this Decision, the authorising officer responsible may apply the changes referred to in the first paragraph in accordance with the principles of sound financial management and proportionality.

*Grants*

Grants may be awarded without a call for proposals to the bodies identified in the Annex, in accordance with the conditions specified therein.

## ANNEX

### **Annual Work Programme for 2018 for support to Union actions and emergency assistance under the Internal Security Fund – Police cooperation and crime prevention<sup>1</sup>**

#### **1. POLICY ORIENTATION**

To ensure a strategic use of the funding available at EU level and streamline its actions, **fives main priority areas for 2018** have been defined in this Annual Work Programme, similar to those targeted in the previous year.

The 2017 Annual Work Programme already addressed financial needs in particular for networks and other bodies in a monopoly situation for a longer, multiannual period. In similar fashion, it listed a large Call and initiatives in the Cybercrime area. For this reason, the budget foreseen for the Information Exchange, Operational Cooperation and Cybercrime policy areas is rather limited in 2018.

##### **1. Counter Terrorism**

Counter Terrorism will remain one of the priorities in 2018. In October 2017, the Commission presented a Counter-Terrorism Package<sup>2</sup>, comprising of a set of operational and practical measures to better defend EU citizens against terrorist threats, increase resilience of society and infrastructures and deliver a Europe that protects. These measures support Member States in protecting public spaces and help deprive terrorists of the means to act, including cutting off sources of terrorist financing and access to explosives precursors.

The prevention of radicalisation remains at the core of the EU's counter terrorism policies. With its Communication adopted in June 2016<sup>3</sup>, the Commission has taken a holistic approach to address this phenomenon, outlining actions in seven areas where cooperation at EU level can support Member States in preventing and countering radicalisation. In July 2017, the Commission established a High-Level Expert Group on Radicalisation (HLCEG-R), which, in December, has presented an interim report with a set of recommendations for further work in this area. In 2018, the Commission will further step up its support to prevent and counter radicalisation all levels, taking into account and implementing the recommendations formulated by the HLCEG-R, including through the Radicalisation Awareness Network (RAN). To counter radicalisation online, the Commission will continue working with internet platforms in the framework of the EU Internet Forum to address terrorists' exploitation of the internet and protect online users, while also exploring possible additional measures.

Work will also continue to counter terrorist financing, in line with the 2016 Action Plan to step up the fight against the financing of terrorism.

## **2. Organised Crime**

The fight against organised crime is one priority for action at EU level towards an effective and genuine Security Union. Organised crime has huge human, social and economic costs in the European Union. In addition, organised crime has clear links with the other priorities for action (terrorism and cybercrime). Organised crime is a key enabler of terrorism, allowing terrorists to acquire weapons and financial means. In recent years, the EU policy cycle has helped improve cooperation between Member States and contributed to creating trust among the relevant actors. Tackling organised crime implies support for action in the various areas, in particular to prevent **money laundering and corruption**, address **environmental crime, migrant smuggling, Joint Investigation Teams, firearms trafficking, drugs trafficking**. Accordingly, both an open call to tackle challenges in the area of the fight against trafficking in firearms and environmental crime as well as a restricted call in the area of migrant smuggling are foreseen. The administrative approach will be promoted through a pilot project while networks specialised in dealing with organised crime will be further supported. Anti-corruption activities including a Eurobarometer and experience-sharing workshops will be funded under procurement.

Trafficking in human being remains a priority area with deliverables as addressed in the Directive 2011/36/EU and in the Commission Communication on "Reporting on the follow-up to the EU Strategy towards the Eradication of Trafficking in human beings and identifying further concrete actions" to disrupt the business model and untangle the trafficking chain, to provide better access to and realise the rights of victims, to increase the knowledge base and improve the understanding of the phenomenon.

## **3. Cybercrime**

The Commission will continue supporting Member States in the correct implementation of Directive 2011/93/EU on combatting the sexual abuse and sexual exploitation of children and child pornography and Directive 2013/40/EU on attacks against information systems. As stated in the 11<sup>th</sup> Security Union Progress Report<sup>4</sup>, the Commission provides funding for the development and delivery of training programmes for law-enforcement agencies on the role of encryption in criminal investigations. The Commission will continue its work on cross-border access to electronic evidence (e-evidence) and makes thus resources available for this process. Finally, given that very few cybercrimes are actually reported, a Eurobarometer survey is a good option to require information on to what extent citizens are confronted with cybercrime.

## **4. Operational Cooperation**

Supporting strengthened cross-border operational police cooperation is a key pillar of EU action in addressing security challenges. and threats to public security including in border regions. The Commission will further support projects aimed at addressing such threats and/or aimed at strengthening cross-border police cooperation, such as joint patrols in cross-border trains, joint threat analysis and enhanced cross-border information exchange.

## **5. Information exchange**

Strengthened information exchange is another key pillar of action EU action in the area of security. Effective information sharing between Member State authorities relies significantly on information systems and databases developed at EU or national level, and the interconnection thereof, as well as the quality of the data. In addition to the support allocated to the work on information systems in the context of ISF-Borders, the Commission intends to further increase the availability of solid forensic data and evidence. This requires, amongst others, the recognition in one Member State of forensics evidence obtained in another Member State, in particular DNA or fingerprint. To increase trust in the quality of Member State's forensic work, accreditation of all forensic laboratories in the EU to a recognised international standard and exchange of best practices are key. This continues to be a priority for the Commission.

The European Network of Forensic Science Institutes (ENFSI) promotes the recognition of forensic data - including electronic and computer data - generated by national forensic institutes and stimulates forensic research across the EU to support the work of the police. In addition, ENFSI may take on emerging tasks resulting from the Council Conclusions on the creation of a European Forensic Science Area by 2020. It is therefore best placed to implement the priorities identified by the Commission in the area of forensics science. Hence ENFSI will benefit from continued support with a view to move towards a European Forensic Science Area by 2020, with a particular focus on the accreditation of forensic laboratories.

Another objective that deserves continued support is to further streamline information exchange within Police and Customs Cooperation Centers (PCCCs). The project should build on previous networking projects by further improving information flows between PCCCs, national authorities, and Europol and support the concept of intelligence-led policing in border areas in which the PCCCs operate.

## **2. LEGAL BASIS**

All Member States, with the exception of United Kingdom and Denmark, participate in "ISF Police"; hence entities established in these participating countries can take part as beneficiaries in the actions that are supported under this financial instrument. Entities established in the United Kingdom<sup>5</sup> or Denmark can only participate on a no-cost basis.

All activities implemented under this work programme shall respect and shall be implemented in line with the rights and principles enshrined in the Charter of Fundamental Rights of the European Union.

Consistency, complementarity and synergies with other Union instruments shall be ensured. As foreseen in article 3(4) and 3(5) of Regulation (EU) n° 514/2014 (Horizontal Regulation), actions in and in relation with third countries under this work programme will be carried out in synergy and in coherence with other actions outside the Union supported

through EU funds, in particular external assistance instruments. The identification and implementation of such actions is fully coordinated with the European External Action Service (EEAS) and relevant Commission's external relations services, including ECHO as far as the Union Civil Protection Mechanism and humanitarian assistance is concerned.

All actions are implemented under direct management unless specifically declared otherwise in the description of the specific action and have their legal base in Articles 8 and 10 of Regulation (EU) of the European Parliament and of the Council establishing the instrument for financial support for police cooperation, preventing and combating crime, and crisis management (ISF Police) (513/2014).

#### 4.1.1. TERRORISM AND RADICALISATION: CALL FOR PROPOSALS

Priority will be given to the following actions:

***(a) Topic 1: call for proposals on reinforcing efforts to counter terrorist financing***

Priorities, objectives, expected results and indicative budget

Countering Terrorist Financing: new initiatives reinforcing the capacity of public and private actors to track and curb terrorist financing better among Member States. The objectives are:

- 1) to make sure that the efforts of private entities and competent authorities are adapted to the new modus operandi of terrorist groups, as for example addressing financial movements related to “low cost” terrorism phenomena which are hard to detect.
- 2) to reinforce the action of private entities and public authorities to prevent and pursue terrorism financing by increasing the understanding of the phenomenon and by use of best practice and/or new tools. For example:
  - development of typologies
  - joint work to address new trends in terrorism financing
  - enable law enforcement to provide feedback on information provided by the private sector to improve quality of reporting
  - sharing police information with private sector entities to assist ongoing investigations

Expected results: Improved quality of suspicious transaction reporting, leading to outcomes such as: increased detection of terrorist financing cases and an increased number of prevented attacks / foiled plots / arrests.

**Indicative budget**

**2 500 000 €**

***(b) Topic 2: call for proposals on preventing and countering violent radicalisation***

Priorities, objectives, expected results and indicative budget

The objective is to develop effective responses and tools to prevent and counter all forms of radicalisation in priority areas such as children and youth, community engagement, local dimension and multi-agency approach and prisons with a focus on mapping, analysis, exchanges and evaluation of existing approaches as well as developing methodologies and approaches with a high degree of transferability.

Expected results: improved capability of relevant stakeholders to identify and address radicalisation leading to violent extremism and terrorism.	
<b>Indicative budget</b>	<b>5 000 000 €</b>

***(c) Topic 3: call for proposals on the Civil Society Empowerment Programme (CSEP) – campaigns with counter and alternative narrative to radicalisation implemented by Civil society organisations***

Priorities, objectives, expected results and indicative budget

The objective is to address the sharp rise in extremists and terrorists use of the internet. To support the production of alternative/counter-narratives, in particular online, their dissemination and monitoring by civil society organisations, and the evaluation of their impact. Expected results: increased number and impact of alternative and counter narratives

***(d) Topic 4: call for proposals on the protection of public spaces, Chemical, biological, radiological and nuclear (CBRN), Critical Infrastructure Protection (CIP), explosives and explosives precursors***

Priorities, objectives, expected results and indicative budget

The objective is to support projects aiming at: <ul style="list-style-type: none"> <li>• Improving the protection of public spaces and other soft targets in line with the EU Action Plan to improve the protection of public spaces;</li> <li>• Improving protection against CBRN attacks in line with the Action Plan to enhance preparedness against chemical, biological, radiological and nuclear security risks;</li> <li>• Enhancing the capacity of Member States' authorities and other stakeholders to implement the Regulation 98/2013, incl, the Commission Recommendation on the implementation of Regulation 98/2013;</li> <li>• Addressing CBRN-E as well as emerging threats to critical infrastructure and public spaces.</li> </ul> Expected results: Improved protection of citizens and infrastructures (both critical and public spaces) against terrorist threats, including from CBRN-E and emerging threats.

*(a) Topic 1: call for proposals for projects on firearms trafficking*

Priorities, objectives, expected results and indicative budget

<p>The objective is to fund projects on the fight against trafficking in firearms, to facilitate joint initiatives and operational actions of EU countries associated with third partners, such as South East Europe and Middle East and North Africa (MENA) countries; improve expertise in the area of firearms trafficking, in particular by enhancing knowledge, detection, investigation and prosecution at EU level and with key third countries; promote best practices inter alia concerning the defragmentation of the relevant information and intelligence along the firearms trafficking routes to and from the EU; safeguard the EU licit market in the field of firearms trafficking; reduce diversion of firearms into criminal hands in the EU.</p> <p>Expected results: increase joint initiatives and operational actions on the fight against trafficking in firearms of EU countries associated with third partners</p>

***(b) Topic 2: call for proposals for projects on environmental crime***

*(a) Projects on PIU interconnectivity*

Priorities, objectives, expected results and indicative budget

<p>The objective is to support Member States in their efforts to ensure the exchange of PNR information between their Passenger Information Units (PIUs) and between the PIUs and Europol, pursuant to Articles 9 and 10 of the PNR Directive (EU 2016/681). This objective is also in line with EAS's priority "information exchange", and with the Council Roadmap action 39. It will however not focus on the technical aspects of the exchange of PNR data, but on building the capacity of the personnel of the PIU to assess the relevance and necessity of the exchange of PNR data. It will also enhance the PIU's ability to exchange best practices concerning the creation of targeting rules and the identification of relevant databases for the processing of PNR data, in accordance with the PNR Directive. A majority of forensics laboratories in the EU are members of ENFSI. ENFSI is therefore the only body with the specific technical competence and outreach capacity in the forensics community in the EU to carry out the proposed action.</p>

- (b) *Project of the Police and Customs Cooperation Centres (PCCC) Network*

Priorities, objectives, expected results and indicative budget

The objective is to further streamline information exchange within PCCCs, and to support the concept of intelligence-led policing in the border areas. Information flows between PCCCs, the national authorities, and Europol should be further improved. The PCCC should also further engage in regional crime analysis and risk assessment. Another task is linking up the information exchange across internal borders via PCCCs to the data flow from the external borders via Hot Spots and Joint Operation Focal Points. Cooperation with the European Border and Coast Guard Agency should be enhanced.

Strengthening the role of PCCCs is also a specific action in the Council's roadmap, progress of which is being monitored by COSI. (Roadmap to enhance information exchange and information management including interoperability solutions in the Justice and Home Affairs area, action 8 on Enhance bilateral law enforcement information exchange - Strengthen Police and Customs Cooperation Centres (PCCCs) and their cooperation with SPOCs while ensuring a centralised (national or at least state level) overview and monitoring of cross-border information exchange).

The grant should build on previous networking projects, which covered inter alia the roll-out of the Europol communication network SIENA to the PCCCs, as well as activities fostering the inclusion of the Western Balkan law enforcement community.

Training, exchange of staff and best practices, as well as networking, e.g. through an annual conference, will further help to achieve the goals.

Expected results: Maintain and strengthen the PCCC Network

#### 4.6. DIRECT AWARD OF ACTION GRANTS TO PROVIDE EMERGENCY ASSISTANCE

Description and objective of the assistance to be provided

The ISF Police shall provide financial assistance to address urgent and specific security-related incident or newly emerging threat which has or may have a significant adverse impact on the security of people in one or more Member States. The emergency assistance will be provided in the form of action grants awarded directly without a call for proposals, following a proposal for action, including a request for funding, submitted to the Commission by one of the eligible entities defined here below in accordance with the provisions of Articles 8 and 10 of Regulation (EU) of the European Parliament and of the Council establishing the instrument for financial support for police cooperation, preventing and combating crime, and crisis management (ISF Police) (513/2014) and in accordance with Article 195(b) of the Financial Regulation. Moreover, in the event of a direct award, this will also be justified by the specific characteristic of the action requiring technical competence and specialisation in accordance with Article 195 (f) of the Financial Regulation. .

#### Type of activities

Specific measures that address particular gaps in enforcement capacity revealed after a crisis situation and/or with a view to preventing such situations reoccurring, especially:

- a) improvement of tools and investigative techniques;
- b) analytical, monitoring and evaluation activities, including threat, risk and impact assessments, which are evidence based;
- c) particularly innovative projects developing new methods and/or deploying new technologies with a potential for transferability to other Member States;
- d) the acquisition, maintenance and/or further upgrading of technical equipment, expertise, secure facilities, infrastructures, related buildings and systems, especially ICT systems and their components.

#### Essential eligibility, selection and award criteria

##### Eligibility criteria

- Applications for emergency assistance can be submitted only by Member States or their regions when the topic is under regional competence, international organisations or Union bodies. Other entities can be involved in the implementation of the action as co-applicants. Applications can also be submitted by any other entity, provided that the entity concerned operates under the effective control of a Member State, or that Member State is co-applicant.
- Emergency assistance may support expenditure which was incurred prior to the date of submission of the request for assistance, if this is necessary for the successful implementation of the action and it is demonstrated that the emergency situation prevailed earlier than the submission of the request.

##### Selection criteria

In accordance with Article 198 of the Financial Regulation , proposals for action shall be evaluated on the basis of the following selection criteria:

- Financial capacity - Applicants and co-applicants must have stable and sufficient sources of funding to maintain their activity throughout the period during which the activity is being carried out and to participate in its funding.
- Operational capacity - Applicants and co-applicants must have the professional resources, competences and qualifications required to complete the proposed action.

The verification of the financial and operational capacity shall not apply to public bodies and international organisations in accordance with Article 198(5), points (c) and (d) of the Financial Regulation.

Award criteria

In accordance with Article 199 of the Financial Regulation, proposals for an action shall be evaluated in particular on the basis of quality of the proposals in the light of the objectives and priorities set ('relevance') and the degree to which the action maximises the overall effectiveness of Union funding ('expected impact of the proposed activities on the situation in the countries concerned').

### **5.1. Types of activities**

In line with Article 3 of Regulation (EU) of the European Parliament and of the Council establishing the instrument for financial support for police cooperation, preventing and combating crime, and crisis management (ISF Police) (513/2014) the types of activities supported for Actions in this Work Programme are:

- a) activities promoting networking, public-private partnerships, mutual confidence, understanding and learning, identification and dissemination of good practices and innovative approaches at Union level, training and exchange programmes as well as organisation of seminars and workshops;
- b) analytical, monitoring and evaluation activities, including threat, risk and impact assessments, which are evidence based and consistent with priorities and initiatives identified at Union level, in particular those that have been endorsed by the European Parliament and the Council and projects monitoring the implementation of Union law and Union policy objectives in the Member States;
- c) projects promoting networking, public-private partnerships, mutual confidence, understanding and learning, identification and dissemination of best practices and innovative approaches at Union level, training and exchange programmes;
- d) projects supporting the development of methodological, notably statistical, tools and methods and common indicators;
- e) the development and the dissemination of new methods and/or deploying new technologies with a potential for significant transferability to other Member States, especially activities aiming at testing and validating the outcome of Union funded security research projects;
- f) particularly innovative projects developing new methods and/or deploying new technologies with a potential for transferability to other Member States;

- g) the development and/or the implementation of tools/toolkits such as (e-)learning materials;
- h) the acquisition, maintenance and/or further upgrading of technical equipment, expertise, secure facilities, infrastructures, related buildings and systems, especially ICT systems and their components at the Union level;
- i) studies;
- j) management of the project and evaluation of activities.

## **5.2. Essential Eligibility, Selection and Award Criteria for Grants - Union Actions**

As a general rule, the eligibility, selection and award criteria will be applied for all calls described in this work programme as follows:

### Eligibility criteria for Open Calls

In order to be eligible for a grant the applicant and co-applicants must:

- a) be legal persons.
- b) be established in an Member State participating in the ISF Police Regulation. In duly justified cases where their participation is necessary to achieve the objectives of the programme, entities established in third countries can participate but only as co-applicant. The eligible third countries will be specified in the call for proposals. International organisations may be established outside of the Member States participating in the ISF Police instrument.
- c) be a public body or a non-profit-making private entity or an international organisation or, if explicitly mentioned in the official Call for proposals when published, private for-profit entities. Union agencies cannot submit applications nor be co-applicants.

Furthermore, Applications:

- a) must be transnational involving at least 2 entities established in 2 different Member States participating in the ISF Police instrument, or, if explicitly mentioned in the official Call for proposals when published, at least 2 entities established in a Member States participating in the ISF Police instrument. Lead applicant must be established in an Member State participating in the ISF Police instrument and cannot be an international organisation.

b)

seeking EU co-funding of less than EUR 250.000 for the Action will be rejected.

### Eligibility criteria for Restricted Calls

In order to be eligible for a grant the applicant and co-applicants must:

- a) Be a Member State participating in the ISF Police Regulation, with possible participation of third countries when explicitly mentioned in the official Call for proposals when published.

Furthermore, Applications:

- a) seeking EU co-funding of less than EUR 250.000 for the Action will be rejected.

### Selection criteria for Open/Restricted Calls and Direct Awards

In accordance with Article 198 of the Financial Regulation, proposals for action shall be evaluated on the basis of the following selection criteria:

- Financial capacity - Applicants and co-applicants must have stable and sufficient sources of funding to maintain their activity throughout the period during which the activity is being carried out and to participate in its funding.
- Operational capacity - Applicants and co-applicants must have the professional competences and qualifications required to complete the proposed action.

In accordance with Article 198(5) of the Financial Regulation, the verification of the financial and operational capacity shall not apply to public bodies and international organisations.

*Award criteria for Open/Restricted Calls and Direct Awards*

In accordance with Article 199 of the Financial Regulation, proposals for an action shall be evaluated on the basis of the following award criteria:

- Relevance;
- Quality;
- Cost-effectiveness;
- European added value, and
- Expected results, dissemination, sustainability and long-term impact of the proposed action.

*Criteria for reallocation of foreseen amounts among calls for proposals*

If for a given call for proposals there are not enough proposals on the ranked list to exhaust the whole amount foreseen for that call or if a direct award application does not absorb the whole amount foreseen for that direct award, the remaining amount may be reallocated to other calls for proposals foreseen by the Annual Work Programme according to the following criteria:

- 1) The total of the remaining amounts from the calls for proposals and direct awards shall be allocated to the projects on the 1<sup>st</sup> rank of the reserve lists of the other calls for proposals, starting with the project with the highest total score received, irrespective of the call for which it was submitted;
- 2) Should two projects have the same score, the project with the higher requested grant (ec-cofinancing) comes first;
- 3) If the remaining amount is not exhausted after listing all projects ranking on the 1<sup>st</sup> place of the reserve list of the calls, the same approach described in point 1 and 2 above will be repeated for projects ranking on the 2<sup>nd</sup> (and thereafter 3<sup>rd</sup>, 4<sup>th</sup> etc.) place of the reserve lists of the calls for proposals.

## 6. PROCUREMENT COVERING ALL POLICY AREAS

Subject matter of the contracts envisaged

### **Counter Terrorism**

1. Policy-supporting studies (2 contracts):
  - a) Study on reducing terrorist propaganda online;
  - b) Studies underpinning the implementation of the High-Level Commission Expert Group on Radicalisation (HLCEG-R) recommendations;
2. RAN Centre of Excellence (support the Radicalisation Awareness Network in its activities, including in particular the exchange of experiences and identification of best practices in the field of preventing radicalisation (between primarily practitioners but also Member States), development of recommendations and guidance as well as support services to Member States and selected priority third countries, support the Civil Society Empowerment Programme (CSEP) through trainings and facilitate the implementation of the recommendations of the High-Level Commission Expert Group on Radicalisation in particular in terms of development of more practical guidance, increased support to Member States (e.g. trainings), evaluation, increased dissemination and engagement with third countries and actors) (1 specific contracts under existing Framework contracts);
3. Supporting the protection of public spaces, addressing Chemical, biological, radiological and nuclear defense (CBRN-E) threats and risks, protecting critical infrastructures and addressing explosives precursors, by conducting studies, organising meetings, workshops and potentially exercises with Member States and relevant third countries (between 6 and 8 specific contracts under existing Framework contracts);
4. Call for tender for consultancy and technical services in the field of CBRNE (2 framework contracts);

### **Organised Crime**

5. Study on possible links between Drug trafficking and Terrorism, Trafficking in Human Beings (THB) and Migrants smuggling as a follow-up to the new Action plan on drugs 2017-2020 (1 new call for tenders, 1 contract);
6. Anti-corruption experience-sharing workshops for Member States' experts as per EU anti-corruption policy (1 specific contract under existing Framework contracts, covering all 4 workshops);
7. Study on integrity incentives for the public sector (1 contract);
8. Study on the subject of modelling and mapping of the risk of serious and organised crime infiltration in legitimate businesses (1 contract);
9. EU-wide risk assessment on financial crime (1 contract);
10. Best practice from law enforcement authorities in locating missing migrant children, study (1 contract);
11. Trafficking in Human Beings (THB): Meetings (EU Civil Society Platform, EU Network of National Rapporteurs or Equivalent Mechanisms) and Studies to follow



up the "User report" in accordance with Article 23 (2) of the Directive 2011/36/EU, a study on the economic, social and human costs of trafficking in human beings, a study for analysing data from Member States for the next Commission report on the progress made to fight THB in the EU, a study on the impact of EU approach against trafficking for sexual exploitation, a study to review the functioning of Member States' national and transnational referral mechanism), initiating EU-wide awareness-raising campaign on THB and organise event marking the EU Anti-trafficking Day , (tendering procedures or 6 specific contracts under existing framework contract);

12. Trafficking in Human Beings (THB): maintenance including content management of the EU anti-trafficking website (1 specific contract under existing framework contract);

13. "Local research corruption correspondents network (LRCC)" (1 specific contract under existing framework contracts);

### **Cybercrime**

14. Follow up Directive CSE (implementation of the 2011/93/EU Directive on combating the sexual abuse and sexual exploitation of children and child pornography (6 specific contracts under existing framework contracts, 5 for meetings and 1 for an evaluation);

15. Expert process on e-Evidence (for the organisation of meetings with Member States for the development and implementation of practical measures to improve cross-border access to electronic evidence; in addition, an external contractor will support the development and implementation of practical measures (6 specific contracts under existing framework contracts, 5 for meetings and 1 for a study);

16. Attacks against information systems. Support Member States in the correct implementation of Directive 2013/40/EU on attacks against information systems by organising workshops to support the implementation of the Directive on the basis of identified weaknesses (1 specific contract under an existing framework contract);

### **Operational Cooperation**

17. Continue ensuring the operations of Directorate-General Migration and Home Affairs' secure zone (maintenance, evolutive upgrade, accreditation of IT systems and project management support) as secure environment supporting information exchange with the European External Action Service (EEAS), Europol, Frontex, crisis management and risk assessment and strategic analysis (1 new framework contract, 20 specific contracts under existing Framework contracts.);

### **Information Exchange**

18. Study on direct exchange of personal data between Europol and private persons (1 specific contract under existing framework contracts)

### **Cross-policy Actions**

19. Meeting and conferences (expert meetings, technical workshops, unforeseen events and extra meetings); Information, awareness raising, studies and communication activities in the field of EU security policy (10 specific contracts, 2 new calls for

tenders);

20. Studies for enhanced capacity building in Member States as well as possibly enhanced third country engagement (6 specific contracts under existing framework contracts)
21. Call for tender for consultancy services in the field of internal security (1 framework contract);
22. Call for tender for technical assistance and logistical support Directorate-General Migration and Home Affairs policies (1 framework contract).

The indicative timeframe for the launch of procurement procedures is Q3-4 2018

Procurement will be implemented directly either by Directorate-General Migration and Home Affairs or via subdelegation or co-delegation to other Directorate Generals.
