On Wednesday and Thursday 21st – 22nd October 2020 RAN hosted its 9th annual RAN Plenary event, the one time in the year when RAN practitioners from all Working Groups come together to reflect on the year that has been and look ahead at the year to come. Due to the continued increasing restrictions surrounding the COVID-19 pandemic, it was the first time that the Plenary had been held online. Despite this, over 100 practitioners from the RAN network, representing all fields of work and from every corner of Europe, were able to participate, and, through an exchange of insights and views, together set priorities for our work in 2021. In this RAN Update we reflect on some of the highlights of the event and hear from some of those that participated, from the European Commission, to Working Group leaders and RAN practitioners.

## EU Commission – A vision for 2021


In her opening address at the RAN Plenary,

EU Commissioner Ylva Johansson called upon the RAN network of practitioners to "make it our mission" in 2021 to build "social cohesion". Reflecting on the current climate precipitated by the COVID-19 pandemic, Commissioner Johansson said that we must offer vulnerable young people a "sense of belonging" and "show them you are part of 'us' (European society) and not 'them' (terrorist and violent extremist groups)". #### Working Group leaders - An introduction

In the summer of this year, RAN welcomed a new set of 18 Working Group leaders, tasked with leading the activity of nine new Working Groups into next year and beyond. The RAN Plenary represented the first opportunity for them to formally introduce themselves to the RAN network and together set priorities for 2021. A series of short videos – '18 people, 18 places' – which introduced the Working Group leaders and the cities they are from, was shown at various moments throughout the Plenary. #### RAN network – A survey



In September this year, a survey was sent out in which practitioners were asked to provide insights that would help each of the RAN Working Groups and their new leaders to carefully plan their work for the coming year. Nearly 1 500 practitioners from the RAN network were asked to complete the survey, representing a fairly even subject matter and geographical spread. Given the current climate, it is no surprise that the impact of the 'COVID-19 pandemic' on P/CVE, 'digital transformation' and 'conspiracy theories' were just some of the topics of most concern to practitioners.
