MIGRATION: A PRIORITY OF THE JUNCKER COMMISSION

pon taking office, European Commission President Jean-Claude Juncker entrusted a Commissioner with special responsibility for Migration to work on a new policy on migration as one of the 10 priorities of the Political Guidelines, the political programme based on which the European Parliament elected the Commission. Ever since, the European Commission has been consistently and continuously working for a coordinated European response on the refugees and migration front.

A COMPREHENSIVE APPROACH TO MIGRATION

o Member State can effectively address migration alone. It is clear that we need a new, more European approach. This requires using all policies and tools at our disposal - combining internal and external policies to best effect. All actors: Member States, EU institutions, International Organisations, civil society, local authorities and third countries need to work together to make a common European migration policy a reality. The European Agenda on Migration presented by the Commission in May 2015 set out the need for a comprehensive approach to migration management. Since then, a number of measures have been introduced. The current refugee crisis, however, requires further, immediate action. A sustainable resolution of the crisis needs a step change in the Union's migration policies - to ensure strong borders, fair procedures, and a system able to anticipate problems.

THE WAY FORWARD

he short term measures necessary to address the immediate crisis are not a long term solution. The Lisbon Treaty foresaw the framing of a common asylum system for precisely this reason. We now not only need to fully implement and enforce what has already been agreed but to accelerate work on the remaining components to create a truly European system.
